1. **CALL TO ORDER AND INTRODUCTIONS**

The meeting was called to order at 1:32 pm by Chief Probation Officer Mark Ferriera. Members of the group introduced themselves.

2. **PUBLIC COMMENT**

No public comment received.

3. **ADOPTION OF MINUTES FROM FEBRUARY 25, 2021 MEETING**

MOTION: Brandon Gillespie. SECOND: Stephanie Kennedy. The minutes of the February 25, 2021 meeting were approved unanimously.

4. **ANALYST UPDATE:**

Crime & Intelligence Analyst Trisha Birchard shared a PowerPoint presentation providing an update of the Day Reporting Center Classes from 2013 to April 2021:

- OUTCOMES-NEVER ATTENDED AND RECIDIVISM:

The group discussed the recidivism rate for non-attendees and methods for reducing recidivism by encouraging participants to attend classes. It was noted that subcommittees through the University of Cincinnati had met several times over the last couple of years to discuss ways to increase participation through different incentives; however, it remains a challenge. Amber Myers, Supervising Probation Officer, discussed previous techniques implemented, including class participants submitting exit

assessment feedback. CPO Ferriera invited the CCP group to send him, Tracie Martin, Amber Myers, or Executive Assistant Eva Carrazco any suggestions via email.

5. PROGRAM UPDATES:

Day Reporting Center (DRC): Tracie Martin, Realignment Manager, from the Probation Department, announced that all DRC classes resumed regularly scheduled operations at a reduced capacity to maintain safety guidelines and social distancing. Community agencies are starting to reopen, providing individuals not eligible for the DRC the opportunity to receive services. Ms. Myers stated that BHRS has resumed servicing in-person groups at the DRC; but, groups continue to wait ~~at REACT~~.

CPO Ferriera verified with Tracie Martin that the Probation Department engaged in five Regional Apprehension Team (RAT) Operations in May. Ms. Martin confirmed the Probation Department's involvement in collaboration with the Sheriff's Department, Modesto Police Department, Turlock Police Department, Riverbank SO, and the Ceres Police Department.

Jail: Deputy Rosales reported the following:

- Facility programming via ZOOM continues to be a work in progress.
- MJC online courses will soon be available in custody.
- A presentation is planned to go before the Sheriff focused on agricultural vocational programming.

Community Assessment Response and Engagement (CARE): Raul Dominguez, CARE Manager from the Probation Department, shared a couple of CARE success stories explaining how embracing CARE services had impacted the clients' previous living situation. Additionally, he reported the following:

- 59 clients from the original 143 clients remain on the list.
- 37 are actively receiving services.
- 6 are pending closure due to six months of no contact.
- 25 were closed due to no contact in six months.
- 21 are linked to services.
- 10 clients have been provided housing.
- 16 deceased.
- 7 went to state prison or hospital.

Mr. Dominguez stated that CARE 2.0 will be presented to the Board of Supervisors in June and will go live at the start of the new fiscal year. He shared a slide presentation outlining the roles that make up the CARE 1.0 and CARE 2.0 Teams.

Cindy Duenas, Director of the Center for Human Services, asked about the CCP funding source for CARE 1.0 and CARE 2.0 and developing a new client list. CPO Ferriera stated that CARE 1.0 positions would be funded by the respected organizations to which the staff members belong, while the CCP would fund CARE 2.0 positions. Raul reported that a new client list for CARE 2.0 would be generated with the assistance of the Crime Analyst, in addition to the same method used to build the client list for CARE 1.0.

District Attorney's Office: Brittany Harker reported the following information:

- 5 clients received restitution education.
- 2 victim restitution requests were submitted.
- 67 Probation Information requests about victim information and Criminal Protective Orders.

Brittany expects data to increase once the Probation Orientation Meetings and Nirvana Women of Hope resume.

Behavioral Health and Recovery Services (BHRS): Chandra Campbell from Behavioral Health and Recovery Services reported that the BHRS services continue to be provided virtually and in person. For last quarter, the IOT Substance Abuse program at the DRC served 77 clients who stayed an average of 55-days and an average regular attendance of 14-days, up from 10-days in previous quarters.

Workforce Development: Doris Foster announced that on July 1, 2021, Workforce Development and Learning Quest will be collaborating to provide more comprehensive services to formerly incarcerated individuals whom Workforce Development serves.

6. **COMMENTS:**

CPO Ferriera reported that the CCP Plan is in the final stages of being finalized and is scheduled to go to the Board of Supervisors on June 8, 2021, at 9 am. A copy of the completed plan will be routed to the CCP group for review.

Cindy Duenas announced that the open house for the Youth Navigation Center is scheduled for July 9, 2021. Furthermore, the Hutton House program and Pathways Transitional Housing will be relocated to this site adjacent to the main office at 2000 W Briggsmore Avenue. An invitation for the open house will be going out to the CCP group.

7. **NEXT MEETING**

The next meeting date will be set for September 2, 2021.

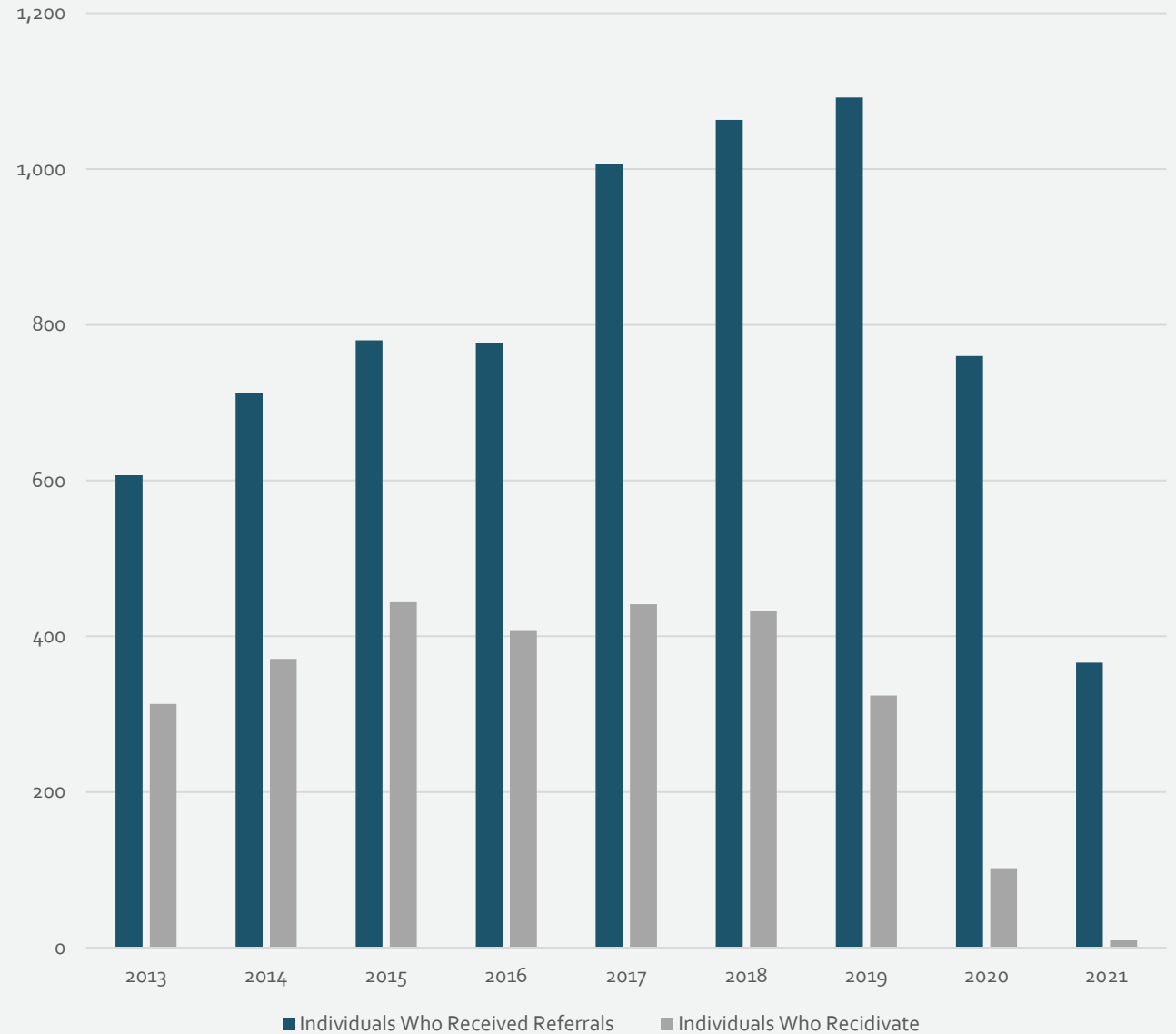

Referral Outcomes & Recidivism

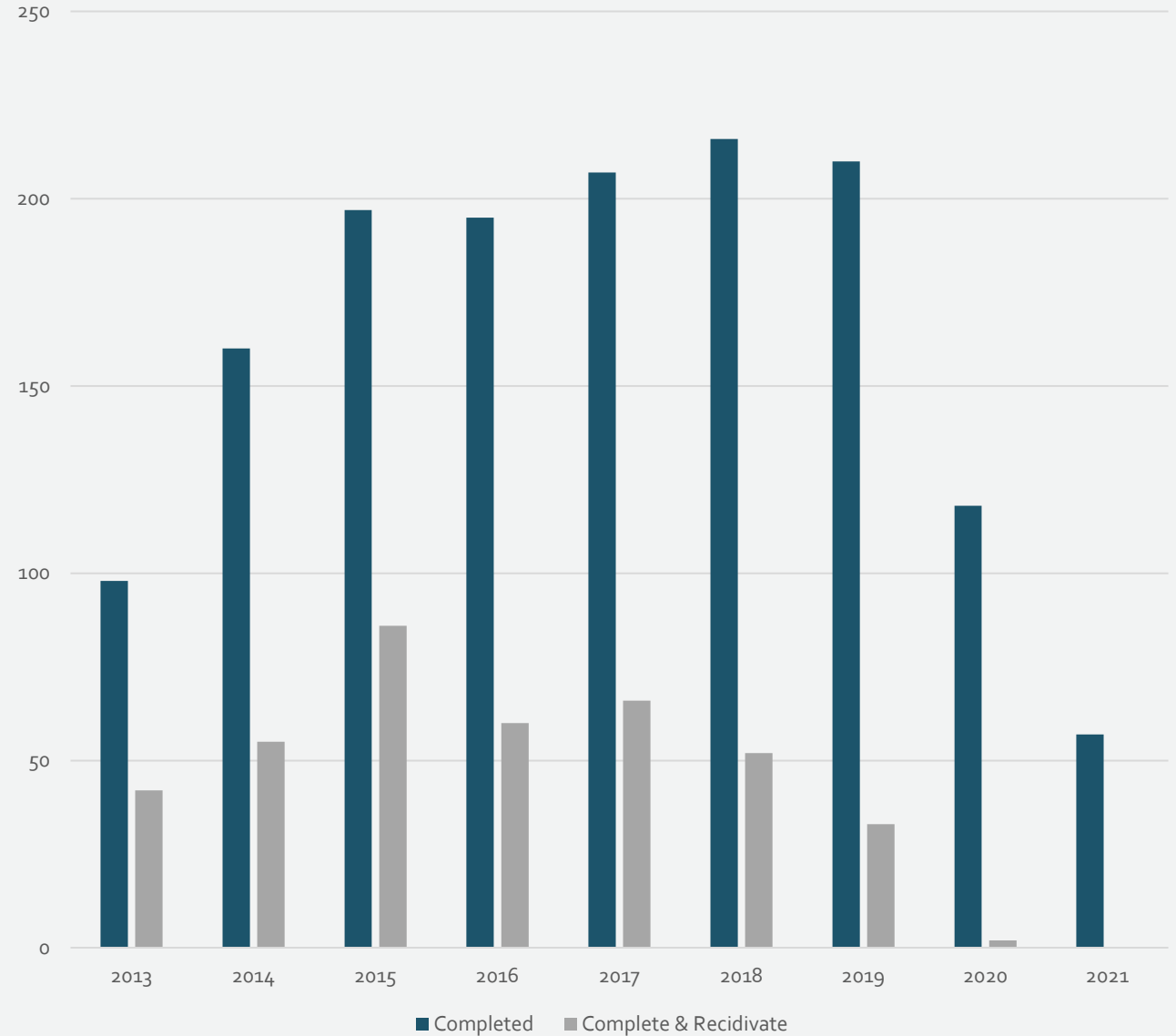
Referrals

- From 2013 to April 2021, 10,837 referrals have been issued to 4,525 individuals.
- 42.5% (1,923) of individuals who received a referral recidivated.



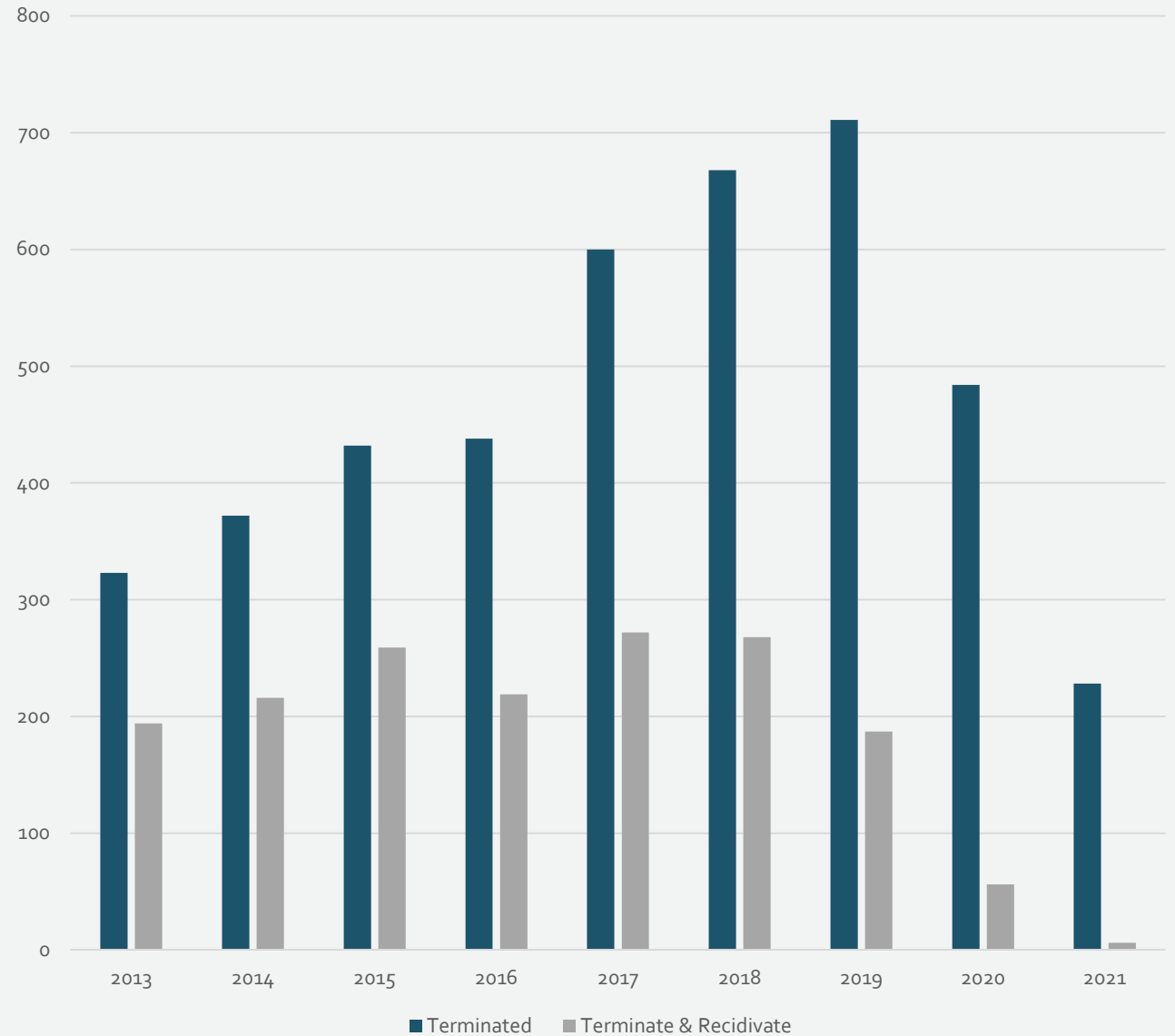
Outcomes – Completion and Recidivism

- From 2013 to April 2021 1,352 individuals completed 1,513 referrals
- As of April 2021, 27.4% or 370 of the individuals who completed recidivated
- 72.6% (982) individuals did **NOT** recidivate



Outcomes – Termination and Recidivism

- 5,657 or 52.1% of the referrals issued resulted in termination
- 1,242 or 42.1% of the 2,948 individuals that terminated from class, recidivated



Outcomes – Never Attended and Recidivism

- 3,374 (31.0%) of the referrals issued resulted in Non-Attendance
- 50.8% (976) of the 2,121 individuals that never attended, recidivated.
