II | <p>The Integrated Forensics Team (IFT) is part of Stanislaus County Behavioral Health and Recovery Services (BHRS), and is located at 500 North Ninth Street, Suite C in Modesto in the Jana Lynn Plaza. It is a Mental Health Services Act (MHSA) funded Full-Service Partnership (FSP) for Justice-Involved individuals who have severe mental health issues and may experience cooccurring symptoms. Participation is voluntary, and the program accepts referrals from Probation, other behavioral health programs, and also accepts walk-ins. Some people may participate for a short term, while others may continue over multiple years. The program is staffed by 5 Case Managers, 2 Clinicians, 1 Registered Nurse, and 1 Psychiatrist. Over half of clientele served are homeless, some chronically.
