WHEREAS, Mr. Bystrom worked in the private sector until graduating from California State University, Stanislaus, with his Bachelors of Arts degree in 1969; and

WHEREAS, Byron began his career with the Stanislaus County Auditor-Controller's office on August 26, 1969; and

WHEREAS, Byron was promoted to the position of Assistant Auditor-Controller in 1987 and then appointed Acting Auditor-Controller by the Board of Supervisors in 1989; and

WHEREAS, Byron E. Bystrom was elected Auditor-Controller by the citizens of Stanislaus County to his first four-year term of office in 1991, second term in 1995, and third term in 1999; and

WHEREAS, Byron E. Bystrom has served the County of Stanislaus and its citizens with dedication, efficiency, fiscal accountability and diligence,
