**DISCUSSION:** The Stanislaus County System Enhancement Fund was established to provide grant funds to local agencies that provide emergency medical services. New requests are considered twice annually for enhancements to the EMS system within Stanislaus County. Funding is considered for all EMS related requests that do not include recurring operational costs.

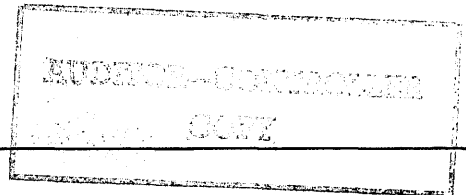
In late January, a committee composed of EMS Agency staff met to recommend allocation of the available funds. A total of \$52,811.89 was available with requests for funding totaling \$113,175.87. The total amount funded was \$52,672.59 of which the Stanislaus County Sheriff's Department Dive Team was allocated \$4,500.83 in order to purchase the following necessary items.
