DISCUSSION: The Sheriff has received grant funds that must be expended in front line law enforcement efforts. Over the years, there have been several positions assigned to the Detective Bureau within the Department that have not been assigned vehicles. Having ready access to a vehicle 24 hours a day, seven days a week will enable these staff members to fulfill their assigned duties. Quite often, when detective supervisors are called to respond to a situation, time is lost in searching for a vehicle.

Additionally, two positions currently assigned to the Special Investigations Unit have not been assigned vehicles. This Unit is responsible for various undercover operations throughout the county and has typically utilized vehicles purchased with asset forfeiture monies.

A need currently exists for these four vehicles and their purchase out of the COPS grant clearly fulfills the requirement that the funds be utilized for front line law enforcement efforts.

It is the request of the Sheriff's Department that these vehicles be purchased and added to the County fleet and then assigned to the Sheriff's Department.

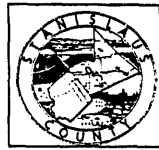
