FISCAL
IMPACT:

The annual cost for agreements with organizational providers and independent Locum Tenens is \$20,574,202. This is an increase of \$1,012,435 from last fiscal year. Increases are generally related to more services provided and rate adjustments. Revenue in the amount of \$20,574,202 is projected from various funding sources to support expenditures. The organization's budget for fiscal year 2001/2002 includes these expenditures and revenues. There is no impact to the County General Fund.

DISCUSSION: In order to fulfill its mission, Behavioral Health and Recovery Services contracts with private and nonprofit organizations to provide behavioral health services to Stanislaus County children, adolescents, adults and older adults. Consistent with Baldrige Award Criteria, the organization views these contract providers as partners in supplying essential services. Contractors were selected on the basis of their expertise with specific populations as well as costs. Continuation of an agreement is based on an organization's ability to deliver the desired outcomes effectively.

Child and Adolescent Services

- Outpatient mental health services for adolescents at various school and outpatient sites.
- Day treatment services for emotionally disturbed children
- Home based mental health services
- Specialized treatment for children with Attention Deficit Hyperactive Disorder
- Residential treatment services for children and adolescents in need of out-of-home care
- Mental health services for kinship families and transitional living services for young adults
- Therapeutic behavioral services for youth

Adult and Older Adult Services

- Comprehensive behavioral health services provided by a regional team in East Modesto
- Stanislaus Homeless Outreach Project
- Locked, long-term residential treatment for individuals with a serious mental illness
- Integrated services for adults with psychiatric disabilities
- Pre-employment services for adults with a mental illness
- Short-term respite care and support
- Locked, long-term residential treatment for individuals with a serious mental illness

DISCUSSION:
(Continued)

Each organizational provider agreement has measurable fiscal and service outcomes. Agreements are monitored throughout the year for compliance through site visits, fiscal reports and services outcome reports. Technical assistance is provided as needed to ensure successful completion of contract requirements.

Contracts are negotiated annually, corresponding with funding allocations. While several contract organizations have successful, long term partnering relationships with Behavioral Health and Recovery Services, all major provider contracts will continue to be reviewed and, consistent with Board of supervisor direction, the organization will seek competitive bids periodically.

The organization experiences occasional funding opportunities and unanticipated increases in the utilization of services throughout the year. Therefore, we are requesting authorization to amend agreements for amounts under \$50,000 throughout fiscal year 2001/2002 to fulfill these unforeseen needs. Amendments to agreements over this amount would continue to be submitted to the Board of Supervisors for approval. Approval of the request will allow increased flexibility to the organization to meet additional service demands or to take advantage of unexpected savings.

As previously discussed with the Board in February and April 2001, there exists an extreme shortage of trained psychiatrists to meet the needs of individuals needing mental health services throughout the State. Extensive recruitment efforts by the organization have not been successful in hiring competent psychiatrists. Because of this shortage as well as vacancies and vacation coverage, the organization contracts with different locum tenens agencies for temporary psychiatrists. It has become increasingly difficult to predict which firm will produce the requested results and in what time frame. Because of the extreme competition, the organization must act quickly to be successful in obtaining the services of a locum tenens psychiatrists. Thus, it is requested that the Director be authorized to negotiate and sign agreements with locum tenens providers for temporary psychiatrists throughout fiscal year 2001/2002 as necessary and consistent with the total amount budgeted.

POLICY
ISSUE:

Board of Supervisor approval of agreements with organizational providers is consistent with the Board priorities of ensuring a safe and healthy community, the delivery of excellent community services and promoting efficient government operations.
