FISCAL  
IMPACT:

The contract amendment for \$2,268 increases the total amount of this contract from \$68,072 to \$70,340. Sufficient appropriations and estimated revenues to support this increase are available in the CSA FY 2000/2001 Budget. The Child Care Programs are 100% federal/state funded. There will be no cost to the County General Fund.

**DISCUSSION:** The California State Budget Act of 2000 provided a Cost of Living Increase (COLA) for CDE General Alternative Payment Contracts. Stanislaus County received \$2,268 to augment our CDE contract #GAPP-0075, increasing the total contract maximum to \$70,340.

The augmentation will be used to provide child care to six additional at risk children linked to the Child Welfare system for the remained of this fiscal year.

The Agency recommends accepting the contract amendment which will supplement the existing CDE Child Care and Development Alternative Payment Contracts effective July 1, 2000 through June 30, 2001.

**POLICY  
ISSUE:**

Approval of the contract amendment supports the Board's priority of economic development by providing child care to recipients who work, and to low-income families who are at risk of becoming dependent on public assistance, and the Board's priority of a safe, healthy community by making child care services available for children who are at risk of abuse and neglect.
