DISCUSSION:

Election Code Section 21500 requires the Board of Supervisors to hold at least one public hearing on any proposal to adjust supervisorial districts prior to a public hearing at which the Board actually votes on district boundaries. In order to receive public input and recommendation on supervisorial redistricting, the Project Steering Committee held three public meetings on July 12, 2001, July 18, 2001, and July 19, 2001, at 7:00 p.m. There were several suggestions regarding the redistricting of supervisorial districts. On August 14, 2001, staff will present to the Board the various alternatives received from the public participation process. On August 28, 2001, the Board will consider all the redistricting options and approve the new supervisorial redistricting boundaries.

POLICY

ISSUES:

The Board of Supervisors, under California law, is charged with the responsibility to conduct supervisorial redistricting after the release of the 2000 census data.
