Mr. Shrock,

Your request for the use of Modesto Reservoir and Woodward Reservoir parks for your men's and women's teams on weekday afternoons from August 20, 2001 through November 30, 2001 was approved by the Board of Supervisors at their meeting on August 14, 2001.

Entrance fees have been waived for participants and staff/volunteers for this time period.

The County requires you to have a \$1 million insurance policy which names Stanislaus County as additional insured on the policy. You will need to give a certificate of insurance to the Parks Department Office, 3800 Cornucopia Way, Suite C, in Modesto, **no later than seven days prior to commencement of your activities**. If your organization does not have an existing insurance policy, you may wish to have another organization or group which has insurance sponsor the event. If your organization is affiliated with a national organization, it is likely that the national organization has insurance which may cover this activity.

It will also be necessary for each participant to sign the Hold Harmless Agreement, which can be obtained from the Public Works Department, before participating in the activity. You can reach them at (209) 525-6550.
