APPROVAL OF FOUR NEW POSITIONS TO THE SUPERIOR COURT IN ACCORDANCE WITH THE FISCAL YEAR 2001/2002 OPERATING BUDGET ADOPTED BY THE COURT AND AMEND THE SALARY AND POSITION ALLOCATION RESOLUTION.

DISCUSSION: The recently approved state budget included funding for Stanislaus County Superior Court for four positions in the Accounting Division.
