SUBJECT: APPROVAL OF A SUMMARY ABANDONMENT OF A PORTION OF SPYRES WAY IN
NORTH MODESTO

DISCUSSION: In accordance with Section 8334 of the Streets and Highways Code, the legislative body of a local agency may summarily vacate an excess right-of-way of a street not required for highway purposes. Mr. Dennis Wilson, representing Mr. Lynn Stinson, has requested that we abandon a portion of Spryes Way. In 1996, Mr. Stinson was required to dedicate a 50-foot-wide strip along the east frontage of Parcel 2 of Parcel Map 36-PM-91. Since that time dedications along the west side of Spryes Way have been completed and the roads ultimate right of way defined. We can now abandoned the east 15 feet of the right-of-way Mr. Stinson dedicated. This will leave the public with the necessary 70-foot-wide commercial right of way. Reservations have been made for utilities.

POLICY

ISSUE: This action is consistent with the Board's policy of providing a safe, healthy community.
