DISCUSSION: On October 2, 2001 your Board adopted Government Code Section 26946, adoption of section 26945.1 outlining the qualifications for Auditor-Controller.

This action required an amendment to County ordinance 2.28.010. There was a clerical and ministerial error in numbering the ordinance. It was listed as 2.08.010 and should have been 2.28.010.
