

Dear Mr. Head:

Your request for use of the Woodward Reservoir for your Roaring 20's Regatta on May 18th and 19th, 2002, was approved by the Board of Supervisors at their meeting of November 20, 2001.

The fees for use of Woodward Reservoir shall be paid to the Parks Department.

The County requires you to have a \$1 million insurance policy which names Stanislaus County as co-insured on the policy. You will need to give the certificate of insurance to the Parks Department located at 1716 Morgan Road, Modesto, CA 95351, **no later than seven days prior to the event.** If your organization does not have an existing insurance policy, you may wish to have another organization or group which has insurance sponsor the event. If your organization is affiliated with a national organization, it is likely that the national organization has insurance which may cover this event.

It will be necessary for each participant of this event to sign the Hold Harmless Agreement before participating in the activity.

Also, in the event of low water which prevents launching boats at other ramps, HobieCat Fleet 20 will need to permit other boaters, if there be any, to launch and retrieve boats at the main ramps.
