DISCUSSION:

Seed Certification

(California Crop Improvement Association)

This agreement stipulates that the Agricultural Commissioner will provide personnel to supervise the seed certification program as provided in the California Agricultural Code and the California Administrative Code. The California Crop Improvement Association (CCIA) will pay in advance to the Commissioner the sum of \$ 300 for Fiscal Year 2001/02 to provide these services.

POLICY ISSUE:

Approval of this agreement will enable the Agricultural Commissioner's Office to oversee the seed certification program which protects the public as well as the agricultural industry and is consistent with the Board Priority of a Safe and Healthy Community.

STAFFING IMPACT:

No additional staff will be necessary.

AGREEMENT
BETWEEN
CALIFORNIA CROP IMPROVEMENT ASSOCIATION

and
AGRICULTURAL COMMISSIONER, STANISLAUS COUNTY

THIS COOPERATIVE AGREEMENT made as of the first day of July, 2001, and between the California Crop Improvement Association and the Agricultural Commissioner, Stanislaus County, hereinafter called the "Commissioner."

That the parties hereto, for and in consideration of the mutual covenants, conditions and agreements herein contained do hereby agree as follows:

1. The Commissioner will provide personnel to supervise the seed certification program as provided in the California Agricultural Code, Division 18, Chapter 2, California Seed Law, Article 7, Sections 52421 and 52422, and the California Administrative Code title 3, Agriculture: Chapter 4, Subchapter 5, Group 3, Seed Inspection; Article 4, Sections 3875, 3876 and 3877.

The Commissioner will also perform other services as may be necessary to maintain an effective seed certification program.

2. The California Crop Improvement Association will pay in advance to the Commissioner the sum of \$300 for the 2001-2002 year, to provide services described in paragraph 1.

3. Upon the termination of the agreement County shall provide an accounting of actual expense. Unless there is a new agreement carrying forward any adjustment, any party with an owing obligation shall reimburse the other party.

4. No alteration or variation of the terms of this agreement shall be valid unless made in writing and signed by the parties hereto, and no oral understandings or agreements not

incorporated herein, and no alterations or variations of the terms hereunder unless made in writing between the parties hereto shall be binding on either of the parties hereto.

5. This agreement shall continue to and terminate on the 30th day of June, 2002, unless succeeded by a new agreement, or may be terminated upon 30 days written notice by either contracting party.
