DISCUSSION: Pursuant to California Elections Code 15372, "The elections official shall prepare a certified statement of the results of the election and submit it to the governing body within 28 days of the election..."

POLICY ISSUE: Pursuant to California Elections Code 15400, "The governing body shall declare elected or nominated to each office voted on at each election under its jurisdiction the person having the highest number of votes for that office, or who was elected or nominated under the exceptions noted in Section 15452. The governing board shall also declare the results of each election under its jurisdiction as to each measure voted on at the election."

STAFFING IMPACT: There is no staffing impact associated with this item.

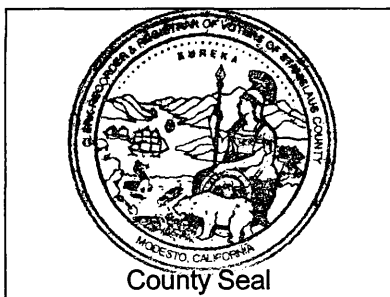


