**RESOLUTION ORDERING AN ELECTION, REQUESTING  
COUNTY ELECTIONS TO CONDUCT THE ELECTION,  
AND REQUESTING CONSOLIDATION OF THE ELECTION**

BOARD OF SUPERVISORS

WHEREAS, pursuant to Elections Code Section 10002, the governing body of any city or district may by resolution request the Board of Supervisors of the County to permit the County Elections official to render specified services to the city or district relating to the conduct of an election; and

WHEREAS, pursuant to Elections Code Section 10400, whenever two or more elections, including bond elections, of any legislative or congressional district, public district, city, county, or other political subdivision are called to be held on the same day, in the same territory, or in territory that is in part the same, they may be consolidated upon the order of the governing body or bodies or officer or officers calling the elections; and

WHEREAS, pursuant to Elections Code Section 10403, whenever an election called by a district, city or other political subdivision for the submission of any question, proposition, or office to be filled is to be consolidated with a statewide election, and the question, proposition, or office to be filled is to appear upon the same ballot as that provided for that statewide election, the district, city or other political subdivision shall, at least 88 days prior to the date of the election, file with the Board of Supervisors, and a copy with the elections official, a resolution of its governing board requesting the consolidation, and setting forth the exact form of any question, proposition, or office to be voted upon at the election, as it is to appear on

the ballot, and upon such request the Board of Supervisors may order the consolidation; and

WHEREAS, the resolution requesting the consolidation shall be adopted and filed at the same time as the adoption of the ordinance, resolution, or order calling the election; and

WHEREAS, pursuant to Elections Code Section 10400, such election for cities and special districts may be either completely or partially consolidated; and

WHEREAS, various district, county, state and other political subdivision elections may be or have been called to be held on June 3, 2008

NOW, THEREFORE, BE IT RESOLVED AND ORDERED that the governing body of the KEYES COMMUNITY SERVICES DISTRICT hereby orders an election be called and consolidated with any and all elections also called to be held on June 3, 2008 insofar as said elections are to be held in the same territory or in territory that is in part the same as territory of the KEYES COMMUNITY SERVICES DISTRICT, and requests the Board of Supervisors of the County of Stanislaus to order such consolidation under Elections Code Section 10400.

BE IT FURTHER RESOLVED AND ORDERED that said governing body hereby requests the Board of Supervisors to permit the Stanislaus County Elections Department to provide any and all services necessary for conducting the election.

BE IT FURTHER RESOLVED AND ORDERED that the Stanislaus County Elections Department conduct the election for the following MEASURE to be voted on at such election:

**Shall the Keyes Community Services District's service charge for street lighting be increased from \$10 to \$20 a year for three years and then to \$25 a year for each parcel of land within the District, effective January 1, 2008?**

To pass this measure must receive a two-thirds (2/3) vote of the electorate residing in the District.

BE IT FURTHER RESOLVED AND ORDERED that the Stanislaus County Elections Department is requested to print the measure text in the Voter's Information Pamphlet of the Sample Ballot for the June 3, 2008 election.
