

The Department does not have any objections to this request and recommends the Board to approve the request as follows:

- By Tuesday, April 29, 2008, no later than 9:00 a.m., require the Rotary Club of Salida to provide the Department of Parks and Recreation, Attention Margarita D. Ramos, Deputy Director, its Certificate of Insurance with a minimum general liability of \$1 million and the Endorsement naming Stanislaus County as an additional insured.
- By Tuesday, April 29, 2008, no later than 9:00 a.m., require the Hold Harmless Agreement (Group) to be completed and returned to the Department of Parks and Recreation, Attn: Margarita D. Ramos, Deputy Director.
- The expected number of person for this event is 100.
- Exclusive Use Fee of \$90 applies.
- Administrative/Reservation Fee of \$10 applies.
- Total Fees of \$100 is payable to Stanislaus County Department of Parks and Recreation no later than Tuesday, April 29, 2008, by 3:00 p.m.
- No alcohol is to be sold or served during the GROUP program.
- The area is to be left in a clean condition.
