

**SUBJECT: REQUEST FROM HOBIECAT DIVISION 3 FOR THE USE OF WOODWARD RESERVOIR FOR ANNUAL REGATTA**

Attached please find a request from the HOBIECAT DIVISION 3 (GROUP), to utilize Woodward Reservoir for its 17<sup>th</sup> Annual Regatta being held May 16, 17, & 18, 2008, Friday, Saturday and Sunday.

The Department does not have any objections to this request and recommends the Board to approve the request as follows:

- By Wednesday, May 14, 2008, no later than 3:00 p.m., require the Group to provide the Department of Parks and Recreation, Attention Margarita D. Ramos, Deputy Director, its Certificate of Insurance with a minimum general liability of \$1 million and the Endorsement naming Stanislaus County as an additional insured.
- By Wednesday, May 14, 2008, no later than 3:00 p.m., require the Hold Harmless Agreement (Group) to be completed and returned to the Department of Parks and Recreation, Attn: Margarita D. Ramos, Deputy Director.
- The expected number of person for this Exclusive Use is 100.
- Exclusive Use of Fischer Point Developed Camping Area at a cost of \$1800. This fee includes overnight developed camping, vehicle entry, vessel entry, and one dog per campsite for a total of 32 sites. In addition the fee covers an additional 18 undeveloped campsites, including vehicle, vessel and one dog per campsite.
- Exclusive Use Fee at \$90.
- An Administrative/Reservation Fee of \$10.
- The total cost of \$1900 is due on or by Wednesday, May 14, 2008, no later than 3:00 p.m. payable to Stanislaus County, Department of Parks and Recreation. Payment to be sent to the attention of Margarita D. Ramos, Deputy Director,
- No alcohol is to be sold during the GROUP event.
- The areas being used are to be left in a clean condition.
- The GROUP will provide all water safety personnel and course markings for the event.
- The GROUP if needed, will provide additional portable toilets at their own expense.

- The GROUP will need to provide to the Manager a draft pass for review for the Hobiecat Division 3 Regatta with sequential numbering 1-50. This draft will need to be provided on or by Wednesday, May 14, 2008, no later than 3:00 p.m.

To Whom It May Concern:


I am writing on behalf of HobieCat Division 3 to request permission to use Woodward Reservoir on Saturday and Sunday, May 17 & 18, 2008, for the purpose of holding our annual regatta. We have hosted this annual race event at Woodward in May for the last 17 years, and have enjoyed it immensely.

We expect to have 50 to 60 boats participating in this event, and would like to camp in the same developed campground at Fisher Point that we have used in the past. Participants will travel to Woodward from locations throughout Northern California. Some may arrive as early as the weekend prior to the Regatta, and everyone typically leaves by Sunday evening.

As in the past, we will need to anchor 3 or 4 inflated plastic marks in the lake for our race course on Saturday and Sunday. We do understand that we must share the lake with other boaters that are not participating in our event, just as we do at the other HobieCat sailing races that are held at other locations throughout the world.

We look forward to the opportunity to work with the folks at Woodward again in 2008.
