WHEREAS, Probation staff are responsible for supervising over 4,000 adult and juvenile offenders in Stanislaus County, and over 1,000 juveniles in custody annually; and,

WHEREAS, Probation staff are trained professionals who provide services and referrals for offenders; and,

WHEREAS, Probation staff work in partnership with community agencies and groups; and,

WHEREAS, Probation staff promote prevention, intervention and advocacy; and,

WHEREAS, Probation staff provide services, support, and protection for victims, and recover over \$500,000 annually for these victims; and,


WHEREAS, Probation staff advocate community and restorative justice; and,
