Dear Supervisors:

With publication of a Notice of Availability in today's *Federal Register*, the Bureau of Land Management and the U.S. Forest Service have initiated a 90-day public comment period on a Draft Programmatic Environmental Impact Statement (PEIS) for leasing Federal geothermal resources in the Western States and Alaska. The agencies are pleased to be taking this next step in an aggressive program to make geothermal energy resources available for responsible development to help meet the Nation's energy needs.

The PEIS has received strong support from the 12 States, local governments, industry, and conservation and environmental groups, and the agencies look forward to continuing to work with you during the public comment period. This involvement is always crucial to the ultimate success of land use planning.

In addition to laying the foundation for environmental analysis of future geothermal leasing under regulations published in 2007, the PEIS also provides site-specific environmental analysis of seven areas with pending geothermal lease applications for lands managed by the BLM and by the Forest Service.

The planning area encompasses about 530 million acres in the 12 States. The development scenario in the Draft PEIS estimates a potential for 5,500 megawatts (MW) of new electric generation capacity from Federal resources by 2015 through 110 new geothermal power plants, and an additional 6,600 MW from an additional 132 plants by 2025. The preferred Alternative analyzes leasing with stipulations, conditions of approval, and best management practices on all public lands with geothermal potential except those that are withdrawn or administratively closed to geothermal leasing. Leasing will be subject to existing laws, regulations, formal orders, stipulations attached to the lease form, and terms and conditions of the standard lease form.
