Approval to Accept a Donation for the Ray Simon Regional Criminal Justice Training Center from the Simon Family Criminal Justice Foundation for the Purchase of Turf Grass for the Physical Fitness Track

DISCUSSION:

The Stanislaus County Sheriff's Regional Training Division has been working with community partners to upgrade and update the physical fitness track area at the Ray Simon Regional Criminal Justice Training Center. The Center serves nine counties in the Central Valley and provides training to hundreds of law enforcement officers.

The Simon Family Criminal Justice Foundation has agreed to donate \$20,946 to fund the purchase of turf grass to renovate the physical fitness track, an area of approximately 100,000 square feet utilized in the daily physical fitness program. Cadets at the Training Center complete an intensive physical training regimen of over 120 hours spread over 24 weeks. Prior to the renovation, the track area was virtually unusable due to the lack of maintenance and serviceable irrigation systems.

This renovation allows current and future peace officers the ability to prepare physically and mentally, for the challenges of keeping our communities safe. It is imperative that law enforcement officers be in good physical condition to meet the rigors of the job.

POLICY ISSUES:

Acceptance and recognition of this donation supports the Board priorities of a safe community and efficient delivery of public services.
