SUBJECT:

Approval to Introduce and Waive the First Reading of an Ordinance to Amend Section 11.08.020 of the Stanislaus County Code, Amending No Parking Zones on Carpenter Road, Toomes Road, Monte Vista Avenue, Latimer Avenue and Pecos Avenue in the Various Unincorporated Areas

STAFF RECOMMENDATIONS:

1. Find that the subject ordinance is not subject to the California Environmental Quality Act (Public Resources Code, Sections 2100 et. seq.).
2. Introduce and waive the first reading of an ordinance amending Section 11.08.020 of the Stanislaus County Code, amending No Parking Zones on Carpenter Road, Toomes Road, Monte Vista Avenue, Latimer Avenue and Pecos Avenue in the various unincorporated areas.

FISCAL IMPACT:

The cost to the County Road Fund for providing and installing fourteen signs is \$250 per installation for an estimated total cost of \$3,500.

Approval to Introduce and Waive the First Reading of an Ordinance to Amend Section 11.08.020 of the Stanislaus County Code, Amending No Parking Zones on Carpenter Road, Toomes Road, Monte Vista Avenue, Latimer Avenue and Pecos Avenue in the Various Unincorporated Areas

DISCUSSION:

On July 29, 2008, Resolution No. 2008-561 was approved by the Board of Supervisor. However, inadvertently the wrong ordinance was attached to the resolution. The ordinance was not approved and did not have a C.S. number assigned to it. Therefore, the Public Works Department is submitting this resolution, with one additional location added, for Board approval.

The Department of Public Works has received several requests for the installation of No Parking Zones at various unincorporated areas of the County (Salida, Denair and South Modesto). The following is a summary of the requests received:

Carpenter Road (South Modesto area): The property owner at 1609 Shaddox Avenue is requesting a No Parking Anytime Zone along the west side of Carpenter Road. Vehicles that are parking on Carpenter Road in front of the property are causing a sight visibility problem at the driveway.

Toomes Road (Salida area): The property owner of a ranch at 619 Toomes Road is requesting a No Parking Anytime Zone along the property. Vehicles that are parking on Toomes Road in front of the property are causing a sight visibility problem at the driveway and hinder farm equipment from performing their farming duties.

Monte Vista Avenue (Denair area): The owner of Santa Fe Storage at 3216 Gratton Road is requesting a No Parking Anytime Zone along the property on Monte Vista Avenue and Gratton Road. Vehicles parking in front of the storage business cause a sight visibility problem for the customers entering and exiting the driveways.

Latimer Avenue (South Modesto area): The owner and the manager of the Broad Acres Mobile Home Park at 821 Latimer Avenue is requesting a No Parking Anytime Zone along the property on Latimer Avenue. Vehicles parking in front of the mobile home park cause a sight visibility problem for residents that enter and exit the driveways daily.

Pecos Avenue (South Modesto area): The owner of A&B Truck Repair at 559 South Ninth Street is requesting a No Parking Anytime Zone along his property on Pecos Avenue. Vehicles parking in front of his business are causing a sight problem for his trucks and customers that enter and exit daily.

The Department of Public Works, Traffic Engineering staff has studied and field reviewed each location. The Department recommends that No Parking Anytime Zones to be installed at these locations to help alleviate these traffic safety issues.

The specific description of the proposed amendment is identified and provided in the text of the proposed ordinance.

AN ORDINANCE AMENDING SECTION 11.08.020
NO PARKING ZONES ON CARPENTER ROAD, TOOMES ROAD,
MONTE VISTA AVENUE, LATIMER AVENUE AND PECOS AVENUE
IN THE VARIOUS UNINCORPORATED AREAS

The Board of Supervisors of the County of Stanislaus ordains as follows:

Section 1. Section 11.08.020 (No Parking Zone) of the Stanislaus County Code is hereby to amend Subsection 446 (Carpenter Road) and Subsection 520 (Toomes Road) to read as follows:

“446. Carpenter Road. On the west side of Carpenter Road from its intersection thereof with Shaddox Avenue north to a point 330 feet of the intersection.

520. Toomes Road. On the west side of Toomes Road from a point 230 feet south of its intersection thereof with Kiernan Avenue south 1820 feet to a point 2050 feet south of said intersection.”

Section 2. Section 11.08.020 (No Parking Zone) of the Stanislaus County Code is hereby amended to add Subsection 523 (Monte Vista Avenue), Subsection 524 (Latimer Avenue), and Subsection 525 (Pecos Avenue).

“523. Monte Vista Avenue. On the north side of Monte Vista Avenue from its intersection thereof with Gratton Road east to a point 380 feet of the intersection.

524. Latimer Avenue. On the north side of Latimer Avenue from a point 675 feet east of its intersection thereof with South Ninth Street, east 215 feet to a point 890 feet east of said intersection.

525. Pecos Avenue. On the north side of Pecos Avenue from its intersection thereof with South Ninth Street south to a point 165 feet of the intersection.”

Section 3. This ordinance shall take effect 30 days from and after the date of its passage, and before the expiration of 15 days after its passage, it shall be published once with the names of the members voting for and against the same in the Modesto Bee, a newspaper in the County of Stanislaus, State of California.


