Approval to Introduce and Waive the First Reading of an Ordinance to Amend Sections 11.08.020 and 11.08.120 of the Stanislaus County Code, Amending No Parking Anytime Zones on Rodden Road and Rancheria Drive in the Northeast Oakdale Area; and, Amending No Truck Parking Zones on Seventh Street in the Keyes Area and Paradise Road and Florette Avenue in the West Modesto Area

STAFF RECOMMENDATIONS:

1. Find that the subject ordinance is not subject to the California Environmental Quality Act (Public Resources Code, Sections 2100 et. seq.).
2. Introduce and Waive the First Reading of an Ordinance to Amend Sections 11.08.020 and 11.08.120 of the Stanislaus County Code, Amending No Parking Anytime Zones on Rodden Road and Rancheria Drive in the Northeast Oakdale Area; and, Amending No Truck Parking Zones on Seventh Street in the Keyes Area and Paradise Road and Florette Avenue in the West Modesto Area.

FISCAL IMPACT:

The cost to provide and install 21 signs at the noted locations is \$250 per installation for an estimated total cost of \$5,250. Funding is to be provided by Public Works' Road Fund and is available in the current budget.

Approval to Introduce and Waive the First Reading of an Ordinance to Amend Sections 11.08.020 and 11.08.120 of the Stanislaus County Code, Amending No Parking Anytime Zones on Rodden Road and Rancheria Drive in the Northeast Oakdale Area; and, Amending No Truck Parking Zones on Seventh Street in the Keyes Area and Paradise Road and Florette Avenue in the West Modesto Area

#### **DISCUSSION:**

The Department of Public Works has received several requests for the installation of No Parking Anytime Zones and No Truck Parking Zones in the Northeast Oakdale, Keyes, and West Modesto areas.

Rodden Road and Rancheria Drive (Northeast Oakdale Area). The neighborhood residents of Rancheria Drive requested No Parking Anytime along Rodden Road and Rancheria Drive. Rafters park their vehicles along these roadways blocking the through lanes.

Seventh Street (Keyes Area). The Keyes Municipal Advisory Council (MAC) requested No Truck Parking on Seventh Street in front of the Keyes Community Services District Office. Trucks that park along the roadway cause a sight visibility problem for the customers and employees that enter and exit the driveways.

Paradise Road and Florette Avenue (West Modesto). The Cambodian Society, Inc., is requesting a No Truck Parking Zone along the east side of Florette Avenue and the north side of Paradise Road. Trucks parking in front of the business are causing a sight visibility problem for customers that enter and exit the driveways.

The Department of Public Works Traffic Engineering staff has studied and field reviewed each location. The Department recommends that No Truck Parking Zones and No Parking Anytime Zones be installed at these locations to help alleviate these traffic safety issues.

The specific description of the proposed amendment is identified and provided in the text of the proposed ordinance.

#### **POLICY ISSUES:**

The Board of Supervisors is asked to determine if this action is consistent with its priorities of providing a safe community, a healthy community, and a well-planned infrastructure system. California Vehicles Code 22506 requires Board approval to change parking zones.

#### **STAFFING IMPACT:**

There is no staffing impact associated with this item.

AN ORDINANCE  
AMENDING SECTION 11.08.020  
NO PARKING ANYTIME ZONES ON RODDEN ROAD AND RANCHERIA DRIVE  
(NORTHEAST OAKDALE AREA); AND,  
AMENDING SECTION 11.08.120  
NO TRUCK PARKING ZONES ON SEVENTH STREET (KEYES AREA),  
PARADISE ROAD AND FLORETTE AVENUE (WEST MODESTO AREA)

The Board of Supervisors of the County of Stanislaus ordains as follows:

Section 1 Section 11.08.020 (No Parking Anytime) of the Stanislaus County Code is hereby to amend subsection 526 (Rodden Road) and subsection 527 (Rancheria Drive) to read as follows:

“526. Rodden Road. On the northerly side of Rodden Road from its intersection thereof with Rancheria Drive to a point 200 feet westerly to the intersection; and on the northerly side of Rodden Road from its intersection thereof with Rancheria Drive easterly to the intersection of Orange Blossom Road.

527. Rancheria Drive. On the westerly side and easterly side of Rancheria Drive from its intersection thereof with Rodden Road to the intersection with Coyote Court.”

Section 2 Section 11.08.120 (No Truck Parking) of the Stanislaus County Code is hereby to amend subsection 23 (Seventh Street), subsection 24 (Paradise Road) and subsection 25 (Florette Avenue) to read as follows:

“23. Seventh Street. On the west side of Seventh Street from its intersection thereof with Jennie Avenue to a point 190 feet south of the intersection.

24. Paradise Road. On the northerly side of Paradise Road from its intersection thereof with Florette Avenue to a point 155 feet easterly of the intersection.

25. Florette Avenue. On the easterly side of Florette Avenue from its intersection thereof with Paradise Road to a point 190 feet northerly of the intersection.”



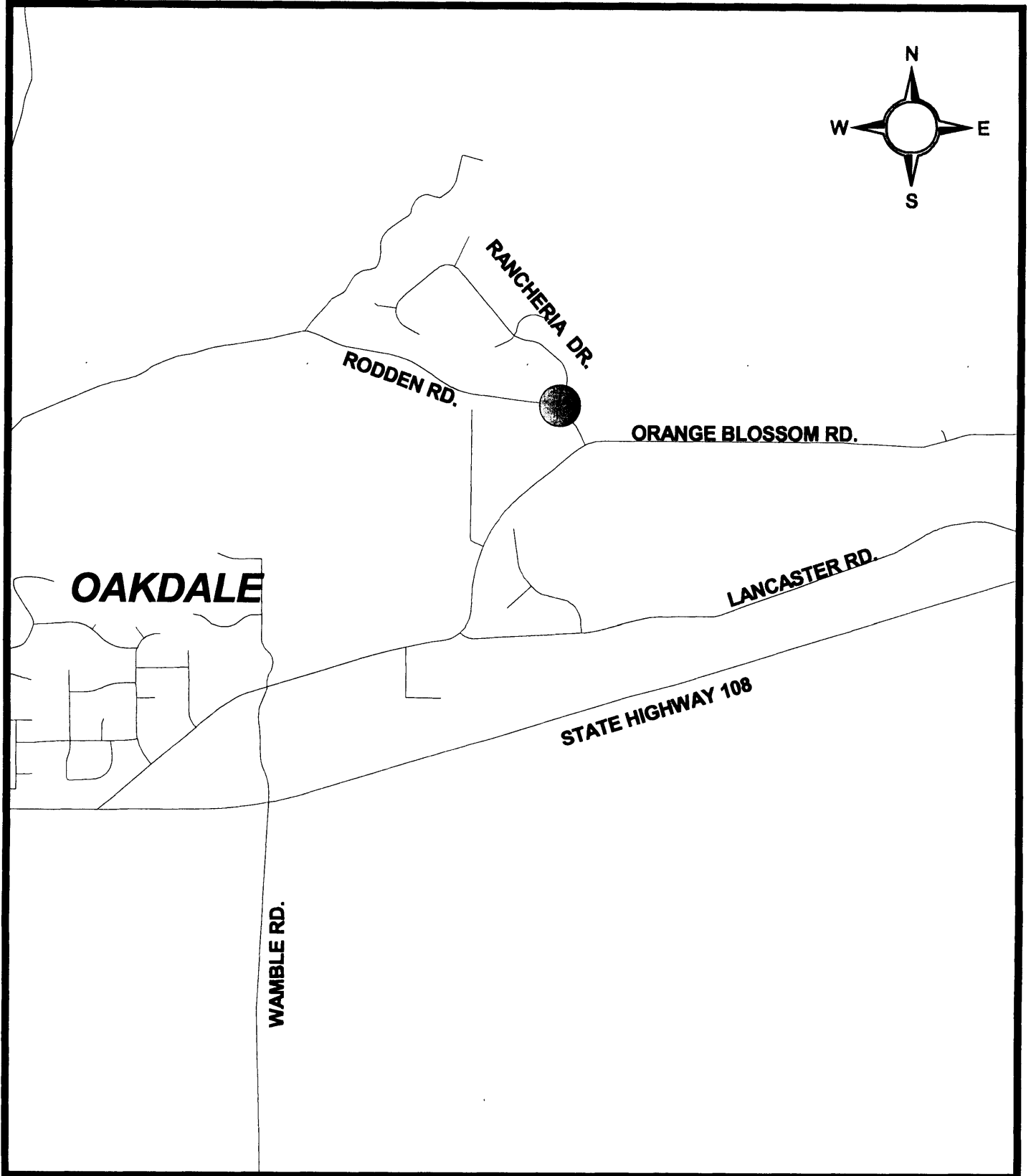
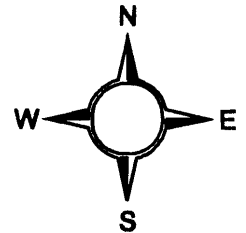

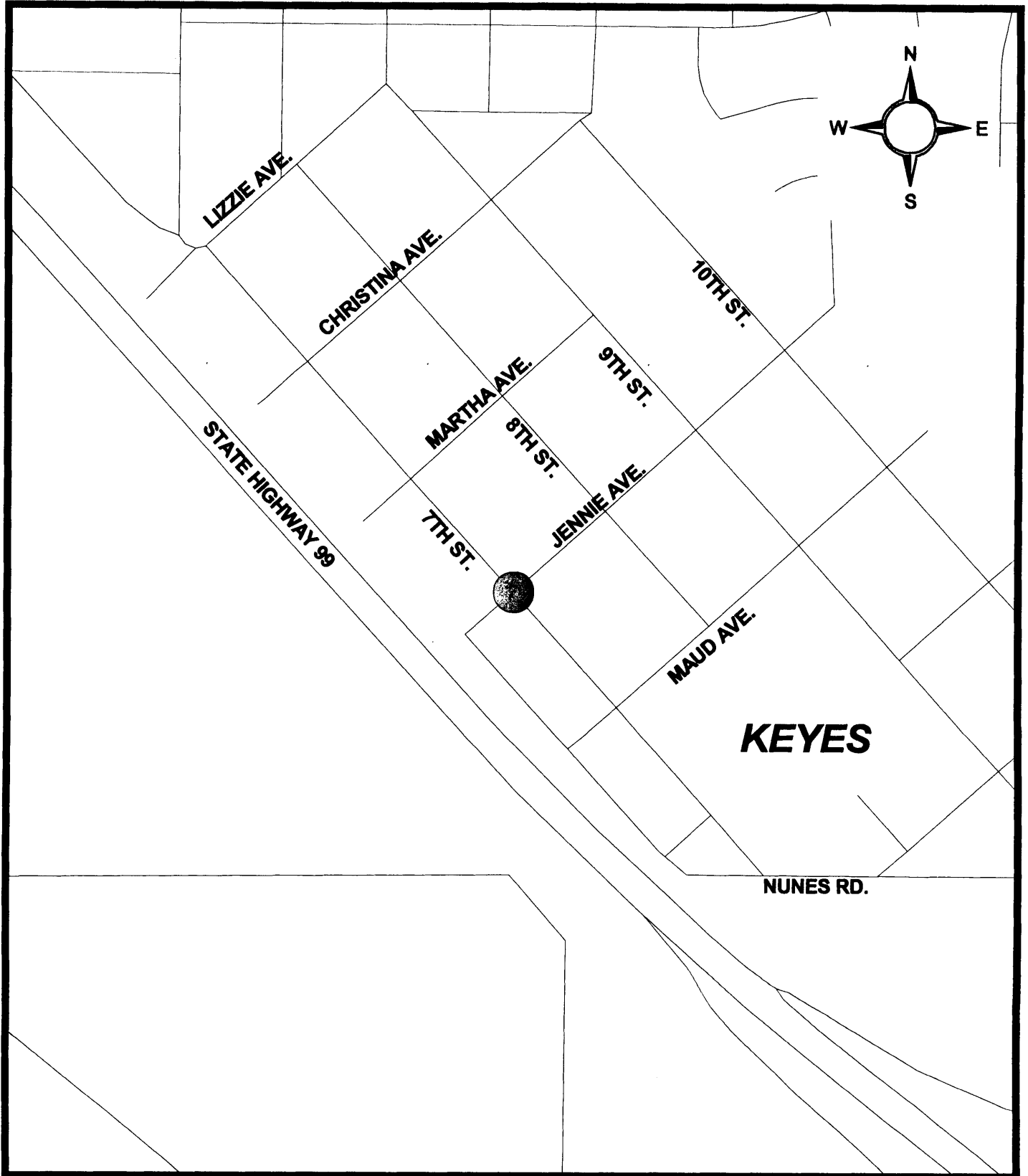
**Stanislaus County Department of Public Works
