## Approval to Purchase a Surplus 1992 Ford F700 Truck from the Salida Fire Protection District for Use by the Sheriff's Department

### **DISCUSSION**

The Sheriff's Department performs a variety of specialized services to our communities. Currently, the Sheriff's Department Major Accident Investigation Team (M.A.I.T.) is in need of a truck to carry equipment and to pull a cargo trailer with additional equipment used by M.A.I.T. The Sheriff's Department became aware that a 1992 Ford F700 truck with approximately 26,000 miles on it was to be surplused from the fleet inventory of the Salida Fire Protection District. Sheriff's Department staff inspected the vehicle and found it to be in excellent condition with low miles, an excellent maintenance history and already equipped with a majority of emergency equipment that would be needed for its operation by the Sheriff's Department.

On November 19, 2008, the Board of Directors of the Salida Fire Protection District authorized its staff to sell the vehicle pursuant to their policy. Sheriff Adam Christianson and Fire Chief Dale Skiles met, conferred and established an agreed upon sales price of \$2,500. This transaction will enable an asset acquired by one public agency to continue to be used by another public agency for the continued benefit of the public and eliminate the need for the Sheriff's Department to consider a more costly purchase alternative.

### **POLICY ISSUES**
