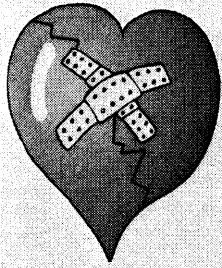


Dear Christine,
