Approval for Central Coast Racers Under the Son to Have Exclusive Use of Frank Raines Regional Park, Deer Creek Camping Area and Recreation Hall from April 24, 2009 to April 26, 2009 for their 2009 Annual Fun Run

DISCUSSION

A request has been received from the Central Coast Racers Under the Son (RUTS) to have exclusive use of Frank Raines Regional Park, Deer Creek Camping Area and Recreational Hall from Friday, April 24, 2009, beginning at 10:00 a.m. to Sunday, April 26, 2009, ending at 3:30 p.m. for their 2009 Annual Fun Run. All off-highway vehicle day use parking areas, picnic area, mountain and riding trails remain open to the public.

Frank Raines Regional Park is located on Del Puerto Canyon Road, in the western part of Stanislaus County, approximately 18 miles west of the City of Patterson. The regional park is functionally divided into two units with more than 2000 acres of open space. The eastern-most section is known as the Minnear Area and designed for non-motorized recreation uses. The western-most section includes the Day Use Area, Deer Creek Campground, and the Off-Highway Vehicle Area.

The Central Coast RUTS is a non-denominational association of off-road enthusiast whose purpose is to be an evangelical outreach to those in need, giving members a chance to become involved in making a difference in the community.

The Department of Parks and Recreation does not have any objections to this request for exclusive use and as such necessitates the Central Coast RUTS to adhere to the following requirements:

- By Thursday, April 23, 2009, no later than 5:00 p.m. require Central Coast RUTS, to provide the Department of Parks and Recreation a Certificate of Insurance with a minimum general liability of \$1 million and endorsement naming Stanislaus County as an additional insured.
- A Hold Harmless (Organization) is required. The original agreement must be completed and returned by Thursday, April 23, 2009, no later than 5:00 p.m.
- A \$100 cleaning deposit for the event is due upon receiving the key to the Recreation Hall. Upon receiving approval by staff, your cleaning deposit will be refunded.
- A \$30 key security deposit is due upon receiving the key to the Recreation Hall. Upon return of the key by Friday, May 1, 2009, no later than 5:00 p.m. the security deposit will be refunded.
- A \$500 deposit for use of the Deer Creek Campground is due by Thursday, April 23, 2009, no later than 5:00 p.m.
- The remaining balance of \$1,225 is payable by Friday, May 1, 2009, no later than 5:00 p.m. Fees include the use of the Recreation Hall, two nights of camping, day use of the Off-Highway Vehicle Area, dogs and horses and additional vehicles.

DISCUSSION (Continued)

- All other fees are applicable for use outside of the Exclusive Use dates.
- The expected number of participants for this event is 150 adults and 50 minors.
- No alcohol may be sold or served during this exclusive use.
- Central Coasts RUTS will provide all security personnel during and course markings for the event.
- Central Coasts RUTS will provide to the Department its pass for review for their 2009 Annual Fun Run by Tuesday, April 14, 2009, no later than 5:00 p.m.
- The Deer Creek Campground and Recreational Hall are to be left in a clean condition.

POLICY ISSUE (S)

The Board should consider whether the approval of this exclusive use request and fees supports the Board of Supervisors' priority of effective partnerships. The Department of Parks and Recreation strive to establish partnerships with organizations that foster human development through use of outdoor spaces to play, exercise and facilitate community connections.
