## NOTICE OF PUBLIC WORKSHOP AND CEQA SCOPING MEETING

### Development of an Amendment to the Water Quality Control Plan for the Sacramento River and San Joaquin River Basins to Establish Total Maximum Daily Loads (TMDLs) to address Organochlorine Pesticides in Several Central Valley Waterbodies

**NOTICE IS HEREBY GIVEN** that the Central Valley Regional Water Quality Control Board, (Central Valley Water Board) staff will hold a California Environmental Quality Act (CEQA) scoping meeting and public workshop to seek input on the environmental information that should be considered in the development and adoption of amendments to the Water Quality Control Plan for the Sacramento River and San Joaquin River Water Basins (Basin Plan) to incorporate TMDLs and program of implementation for discharges of Organochlorine (OC) pesticides in several Central Valley waterbodies. Impaired waterbodies on the 303(d) list that will be addressed by this project include reaches of the San Joaquin River, the lower Tuolumne River, the lower Stanislaus River, Orestimba Creek, the lower Merced River, the lower Feather River, the Colusa Basin Drain, and eight portions of the Sacramento-San Joaquin Delta (Delta waterways) located in Region 5 including the Stockton Ship Channel.

This meeting and workshop will provide participants with: (1) an opportunity to comment on the appropriate scope and content of the proposed amendment and environmental documentation to be prepared pursuant to CEQA (Public Resources Code section 21000 et seq.) and the Central Valley Water Board's certified regulatory program for basin planning (California Code of Regulations, Title 14, section 15251, subdivision (g); and Title 23, section 3775 et seq.); and (2) an overview of the conditions in the project area.

Comments should be limited to identifying the range of actions, alternatives, mitigation measures, reasonably foreseeable means of compliance and their impacts, and potential significant environmental effects to be analyzed in-depth in the development of this CEQA project. #### NOTICE OF PUBLIC WORKSHOP concerning TRIENNIAL REVIEW FOR THE SACRAMENTO RIVER AND SAN JOAQUIN RIVER BASINS

The Regional Water Quality Control Board (Regional Board) is beginning the process of reviewing its Water Quality Control Plan for the Central Valley Region, Sacramento River and San Joaquin River Basins (Basin Plan). This Basin Plan covers the watersheds of the Sacramento and the San Joaquin Rivers. The Basin Plan identifies beneficial uses of surface water and groundwater, establishes water quality objectives to protect beneficial uses, and describes an implementation plan to achieve the objectives.

The Regional Board will hold a public workshop, conducted during the August 2009 Central Valley Water Board meeting, to receive comments on basin plan elements that may need amendment. The public workshop is tentatively scheduled as follows:

- Time: 8:30 am

The purpose of the triennial review is to identify high priority basin planning issues that the Central Valley Water Board will direct basin planning efforts over the next three years. Amendments to the basin plan may occur as a result of the triennial review priorities but are not part of the triennial review process.

The public is encouraged to submit written comments by **22 July 2009** on Basin Planning issues the Regional Board should consider in this triennial review. Comments should be submitted to Betty Yee, Regional Water Quality Control Board, Central Valley Region, 11020 Sun Center Drive, #200, Rancho Cordova, CA 95670. In the comments, please provide a detailed description of the issue, a brief statement of reasons for the addition or deletion of an issue, and recommendation on the priority that should be given to that particular issue. At the workshop, staff will summarize the written comments and interested persons will be provided the opportunity to present oral comments to the Regional Board. Following the workshop, staff will review oral and written comments and prepare final recommendations in a workplan for Regional Board consideration at a future public hearing. Staff will identify which issues are expected to be addressed in the next three years with existing resources and which require additional resources. The workplan will be available for comments prior to the hearing.

Non-Regulatory Amendments to the Water Quality Control Plan for the Sacramento River and San Joaquin River Basins to Correct Editing Errors and Update Language

The Central Valley Regional Water Quality Control Board (Central Valley Water Board or Board) will hold a public hearing to consider adopting amendments to the Water Quality Control Plan for the Sacramento and San Joaquin River Basins (Basin Plan). The proposed amendments will correct editing errors and will update outdated language. At the public hearing, the Board will also consider certifying draft environmental documents prepared pursuant to Public Resources Code section 21080.5 and California Code of Regulations, title 23, section 3775 et seq., that determine that the proposed action does not have any potential adverse environmental effects. After hearing testimony, the Central Valley Water Board may choose to act on the proposal, or may choose to continue or close the hearing and vote on the proposal at a future meeting. The public hearing, to be conducted during the Central Valley Water Board meeting, is scheduled at the time and location noted below:
