Dear Mr. O'Brien,

It is with regret that I must tender my resignation as a member of the board of Oakdale Rural Fire Protection District. After being on the board only for a single year I can positively inform you that they are in need of more assistance than I can provide. There are more special (personal) interests being fulfilled than there are necessary goals being met.

To familiarize you with some of the problems that any future board members will be entering into I will list some of my concerns.

1. One of the board members is solely looking out for her son (a firefighter) and her good friend (the fire chief). She has even gone as far to use her position to attack or direct action against specific firefighters without just cause.
2. Firefighters are hostile and threaten law suits with union action at every point that they don't get their way. The Brown Act prevents us from delivering proper information to them and the community, which then results in an incorrect and indefensible reaction by the community and firefighters towards the board.
3. At each meeting firefighters and members of the community are recording and then trying to pick at each action taken by the board and even specific members for fault. While some insulation from personal liability is granted to board members, even a board member with the best intent is accepting some personal liability risk in the atmosphere that has been created.
4. Budget problems are solvable, but will never be agreed upon or accomplished because of firefighters and special interest board members. The department currently runs on almost 90% of the budget allocated to the employees and a mere 10% allocated to maintain the facilities and equipment.

I could list additional items, although I feel it is unnecessary. The bottom line is that it is going to be very difficult to save or even help the department in its current state. I know that the firefighters feel that I am one of the individuals that is looking out for the

department, the community and them, and I hope my resigning will help them to realize what they are doing to themselves.

Please take care to appoint replacement Directors that do not have any special interests in mind when requesting a seat on the board. I can assure you if things don't improve, I will not be the last letter of resignation that you will receive because of the hostility and chaos that exists at Oakdale Rural Fire Protection District.

Thank you for the opportunity to get involved with my community and I can honestly say that I did the best I felt could be done for the department in my short time spent as a Director. I wish you the best of luck in finding a replacement and would like to offer my input if you feel this is an issue of which you would like to become more involved.
