Approval for First Congregational Church of Salida to Have Exclusive Use of Salida Park, Northwest Turf Area on July 30, 2009, August 13, 2009, and August 27, 2009, for their Salida Christian Community, "Music Concerts in the Park" Series

DISCUSSION

A request has been received from First Congregational Church of Salida to have exclusive use of Salida Park, Northwest Turf Area on Thursday, July 30, 2009; Thursday, August 13, 2009; and Thursday, August 27, 2009 each day beginning at 5:00 p.m. and ending no later than 9:00 p.m. for their Salida Christian Community, "Music Concerts in the Park" series.

The "Music Concerts in the Park" series is an annual summer pastime event. Event coordinators have successfully met department requirements in past years and has partnered with many business and civic organizations in the community of Salida.

The Department of Parks and Recreation does not have any objections to this request for exclusive use and as such necessitates First Congregational Church of Salida to adhere to the following requirements:

- First Congregational Church shall work with other necessary groups, organizations, or other governmental personnel as determined by applicable codes, laws, and regulation to ensure a safe event.
- By Wednesday, July 29, 2009, no later than 5:00 p.m. require First Congregational Church, to provide the Department of Parks and Recreation a Certificate of Insurance with minimum general liability coverage of \$1 million and endorsement naming Stanislaus County as an additional insured.
- A Hold Harmless Agreement (Organization) is required with all concert dates. The original agreement must be completed and returned by Wednesday, July 29, 2009, no later than 5:00 p.m.
- The expected number of spectators is less than 100 persons per concert date.
- Alcohol may not be sold, served, or consumed on County property during this exclusive use.
- The area is to be left in a clean condition with all waste, debris, and garbage removed from County premises upon conclusion of each exclusive use event.
- No vehicles may be driven on the Salida Park turf.
- Portable restrooms shall not be placed on Salida Park turf.

POLICY ISSUE (S)

The Board should consider whether the approval of this exclusive use request and waiver of fees supports the Board of Supervisors' priority of effective partnerships. The Department of Parks and Recreation strive to establish partnerships with organizations that strengthen
