> RE: Kindred Hospital Modesto Notice pursuant to the Worker Adjustment and Retraining Notification Act and California Labor Code §§1400 *et seg.*

Dear Mr. Rowe:

We are writing to inform you that Kindred Hospital Modesto, located at 730 17th Street, Modesto, CA 95354 ("the Hospital") will be closing. We have also notified the State of California Employment Development Department, Mayor Jim Ridenour, and Dick Monteith of the Stanislaus County Board of Supervisors of Kindred Hospital Modesto's closing.

This closing will affect the entire Hospital and is expected to be permanent.

Enclosed in Attachment A is a list of the job titles of the positions to be affected, and the number of affected employees in each job classification. The employees will be laid off permanently on Friday January 29, 2010 pending our ability to relocate the hospital patients. If all of the patients are not discharged by this time, then sufficient staff will be retained to care for the patients until they are all discharged. Bumping rights do not exist. None of the affected employees are represented by a union.

If we do not have work for employees at any time before the date of their permanent layoff and have not offered them a transfer, we will place them on *paid* leave and will continue their regular pay and benefits until the date of their permanent layoff. Of course, employees will not receive this pay or benefits if they resign at any time prior to the date of their permanent layoff.
