

At-Large to Turlock MAD Board of Trustees

Dear Supervisors Chiesa and DeMartini,

The Turlock Mosquito Abatement District's Stanislaus County Representative Dan Peterson's term of office will expire December 31, 2009. Mr. Dan Peterson has indicated that he would like to be reappointment. Mr. Peterson has served on the board for the past 14 years. He has consistently attended the meetings and took part in the decision making process at board meetings. He is currently serving as the board secretary. The board generally meets on the 3<sup>rd</sup> Monday of each month at 7:00 p.m. at the District office at 4412 N. Washington Road, Turlock.

Historically, Mr. Peterson is a joint appointment between Districts 2 and 5 as he is an at-large appointment.

According to the Following section of the California Health and Safety Code the appointing authority can appoint their representative to serve either a two-year term or a four-year term.

Health and Safety Code, Division 3, Chapter 1, Mosquito Abatement and Vector Control Districts, section 2024 (a) and (b) states that: “ (a) Except as provided in Section 2023, the term of office for a member of the board of trustees shall be for a term of two or four years, at the discretion of the appointing authority. Terms of office commence at noon on the first Monday in January. (b) Any vacancy in the office of a member appointed to a board of trustees shall be filled pursuant to Section 1779 of the Government Code. Any person appointed to fill a vacant office shall fill the balance of the unexpired term.


The District recommends that you take action to appoint a representative before the Turlock MAD board meeting in January 2010 so that there is no interruption of representation for the County.
