STAFF RECOMMENDATIONS:

3. Approve the waiver of fees for exclusive use and reservation for this outreach service.

Approval for the Nuevo Pacto Church, a Partner of Nineveh Outreach, to Have Exclusive Use of an Area Within Fairview Park on Saturdays Beginning April 10, 2010, Ending December 4, 2010 and Waiver of Fees for Exclusive Use

DISCUSSION:

A request has been received from the Nuevo Pacto Church, a partner of Nineveh Outreach efforts, to have exclusive use utilizing an area within Fairview Park (Attachment A) for their second year of serving the County's children, families and individuals in need of food and clothing. The Nuevo Pacto Church will utilize Fairview Park each Saturday beginning April 10, 2010 from 8:00 a.m. to 12:00 p.m. and ending Saturday, December 4, 2010.

Nineveh Outreach is a longstanding outreach organization serving the community since 1997. As a partner of Nineveh Outreach, the Nuevo Pacto Church will continue its second year of operation at Fairview Park distributing groceries and prepackaged food to the community while sharing messages of hope and faith. In 2009, over 75 families gathered at the park with over 40 children involved in activities each week. A total of 4,564 bags of groceries were distributed in the 8-month period.

The Department of Parks and Recreation does not have any objection to this request for exclusive use and as such necessitates the Nuevo Pacto Church to adhere to the following requirements:

- The Nuevo Pacto Church, Nineveh shall provide the Department of Parks and Recreation a Certificate of Insurance with a minimum of \$1 million general liability coverage and shall provide accompanying endorsements naming Stanislaus County as an additional insured. The Certificate of Insurance shall be provided no later than 5:00 p.m., Wednesday, April 7, 2010.
- An Organization Hold Harmless Agreement is required. The original agreement must be completed and returned no later than 5:00 p.m., Wednesday, April 7, 2010.
- Nuevo Pacto Church, Nineveh Outreach staff/volunteers will be responsible for ensuring the park is free of litter and debris prior to leaving the park each day. Nuevo Pacto Church, Nineveh Outreach staff will contact Department staff should graffiti and vandalism issues be noticed while in the park.
- All irrigation concerns will be coordinated with Department staff to ensure grounds are useable and do not interfere with activities.
- Should an annual community event be scheduled and authorized by the Board of Supervisors at this park location, said event will take precedence over the Nuevo Pacto Church, Nineveh Outreach activities unless mutually agreed upon by the community event organizer and Nuevo Pacto Church, Nineveh Outreach staff.
- No alcohol shall be sold, served or consumed during Nuevo Pacto Church, Nineveh Outreach activities.
- The expected number of persons for each event date is 100.
