Dear Mr. Grover:

Pursuant to the Federal and California Worker Adjustment and Retraining Notification ("WARN") Acts, Valley Fresh, Inc. ("Valley Fresh") hereby provides the following notice:

1. Valley Fresh is closing its facility at 680 D Street, Turlock, California. All employees will be permanently laid off as a result of the plant closing.

2. The permanent employment separations will occur in two stages. The first stage will be effective June 25, 2010 ("Stage One"). The second stage will be effective October 29, 2010 ("Stage Two").

3. A total of 62 employees will be permanently laid off in Stage One. The job titles of the positions affected in Stage One, as well as the number of affected employees in each job classification, is attached to this letter as Exhibit A.

4. At total of 101 employees will be permanently laid off in Stage Two. The job titles of the positions affected in Stage Two, as well as the number of affected employees in each job classification, is attached to this letter as Exhibit B.

5. United Food and Commercial Workers Local 8 represents the affected employees. Contact information for the chief elected official of this union is as follows:
