Approval for the Holy Family Catholic Church to have Exclusive Use of Salida Park Beginning August 14, 2010, and Ending August 15, 2010, for their Twelfth Annual Parish Festival

## **DISCUSSION**

A request has been received from the Holy Family Catholic Church to have exclusive use of Salida Park beginning at 12:00 p.m. (Noon) on Saturday, August 14, 2010, and ending no later than 11:00 p.m. on Sunday, August 15, 2010, for their Twelfth Annual Parish Festival.

The Holy Family Catholic Church has been serving the community of Salida for the past eleven years while meeting in a local school's cafeteria since 1999. The church, the newest parish in the Stockton Diocese was founded in 2006 when a lease of property became effective. The church is identified by its commitment to the community, building strong relationships with those in the community, and supporting its community through many challenges.

The Department of Parks and Recreation supports this request for exclusive use providing that the Holy Family Catholic Church adheres to the following requirements:

- The Holy Family Catholic Church shall provide the Department of Parks and Recreation a Certificate of Insurance with a minimum of \$1 million liability coverage and shall provide accompanying endorsement naming Stanislaus County as an additional insured. The Certificate of Insurance shall be provided no later than 5:00 p.m., Wednesday, August 11, 2010.
- An Organization Hold Harmless Agreement is required. The original must be completed and returned no later than 5:00 p.m., Wednesday, August 11, 2010.
- The Holy Family Catholic Church shall work with all other necessary groups, organizations, or other government personnel as determined by applicable codes, laws, and regulations to ensure a safe and secure event.
- This community event is open to the public and the expected number of community members is estimated at 5,000.
- Alcohol may not be sold, served, or consumed on County property during this exclusive use.
- The area of use and surrounding area shall be left free of litter, debris, and garbage and all shall be removed from County premises upon conclusion of this exclusive use event.
- No portable toilets or dumpsters shall be placed on any lawn area of the park; placement shall be exclusively on concrete or paved surfaces and cannot block any accessible walkway.

- No vehicles may be driven onto the park.
- The Department does not guarantee electricity at the facility.
- The Department will ensure irrigation does not interfere with this exclusive use.

### **POLICY ISSUE**

The Board of Supervisors should determine if approving the Holy Family Catholic Church Twelfth Annual Parish Festival is consistent with its priority of Effective Partnerships.
