Approval for the Greater Yosemite Council, Boy Scout Troop No. 2, to have Exclusive Use of Kiwanis Camp from September 17, 2010, to September 19, 2010, for Overnight Camping Activities

DISCUSSION:

A request has been received from the Greater Yosemite Council, Boy Scout Troop No. 2, to have exclusive use of Kiwanis Camp beginning at 10:00 a.m. on Friday, September 17, 2010, and ending no later than 5:00 p.m. on Sunday, September 19, 2010, for their overnight camping activities.

Kiwanis Camp (Attachment A) is located in within La Grange Regional Park. This location was established in 1980 by Kiwanis Club of Greater Modesto and is home to remnants of the historic gold dredge camp and adjacent to the Joe Domecq Wildlife Area.

La Grange Regional Park is the County's most diverse park with over 700 acres consisting of eleven sites within the town of La Grange. Six of the eleven sites hold historic significance, along with an additional 225 acres of river bottom along the Tuolumne River; the Joe Domecq Wildlife Area, the off-highway vehicle recreation area, the La Grange Gold Dredge Area, and the Historical Museum.

The Department of Parks and Recreation supports this requests for exclusive use providing that the Greater Yosemite Council, Boy Scout Troop No. 2, adheres to the following requirements:

- The Greater Yosemite Council, Boy Scout Troop No. 2, shall provide the Department of Parks and Recreation a Certificate of Insurance with a minimum of \$1 million liability coverage and shall provide an accompanying endorsement naming Stanislaus County as an additional insured. The Certificate of Insurance shall be provided no later than 5:00 p.m. Thursday, September 16, 2010.
- The Greater Yosemite Council, Boy Scout Troop No. 2, shall provide the Department of Parks and Recreation a copy of the approved activity as provided by the Greater Yosemite Council authorizing the Troop's activity.
- An Organization Hold Harmless is required. The original must be completed and returned no later than 5:00 p.m. Thursday, September 16, 2010.
- Individual Hold Harmless Agreements for each participant shall be signed by their parent or guardian and must be completed prior to participating. All original agreements are to be returned to the Department of Parks and Recreation no later than 5:00 p.m. on Thursday, September 16, 2010. In unforeseen circumstances determined by the Department, the event organizer for the Greater Yosemite Council, Boy Scout Troop No. 2, may submit the agreements no later than 5:00 p.m. Wednesday, September 22, 2010.
- Individual Hold Harmless Agreements for each volunteer must be completed prior to participating. All original agreements are to be returned to the Department of Parks and Recreation no later than 5:00 p.m. on Thursday, September 16, 2010. In

unforeseen circumstances determined by the Department, the event organizer for the Greater Yosemite Council, Boy Scout Troop No. 2, may submit the agreements no later than 5:00 p.m. Wednesday, September 22, 2010.

- A \$30.00 security deposit is due at the time the facility key is picked up. The key may be picked up on Wednesday, September 15, 2010, or thereafter during business hours. The key security deposit will be forfeited if the facility key is returned later than 5:00 p.m. Wednesday, September 22, 2010.
- The expected number of participants and volunteers is 40.
- No alcohol may be sold, served, or consumed during this exclusive use.
- Kiwanis Camp shall be left in a clean condition free of litter and debris.

POLICY ISSUE:

Approval of this agenda item supports the Board of Supervisors' priority of Effective Partnerships by partnering with community based organizations fostering human development through the use of outdoor spaces to play, exercise, and discover the County's history.
