AN ORDINANCE AMENDING STANISLAUS COUNTY CODE, SECTION 11.08.070
RELATING TO NO PARKING ZONE ON MARSHALL STREET,
IN THE TURLOCK AREA

**THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS ORDAINS AS
FOLLOWS:**

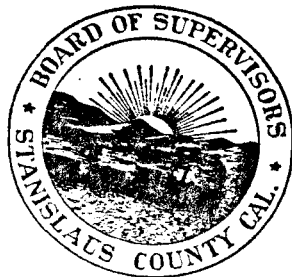
Section 1. Amend the Stanislaus County Code, Title 11, Chapter 11.08, Section 11.08.070 (No Parking Zone) to add Subsection 535 (Marshall Street) as follows:


“535. Marshall Street. On the south side of Marshall Street from its intersection thereof with Johnson Road to its intersection with Quincy Road; parking is prohibited from 7 AM to 2 PM on Tuesdays.”

Section 2. This ordinance shall take effect 30 days from and after the date of its passage, and before the expiration of 15 days after its passage, it shall be published once with the names of the members voting for and against the same in the Modesto Bee, a newspaper in the County of Stanislaus, State of California.

Upon motion of Supervisor O'Brien, seconded by Supervisor Monteith, the Foregoing ordinance as passed and adopted at a regular meeting of the Board of Supervisors of the County of Stanislaus, State of California, this 7th day of December, 2010, by the following called vote.





ZONE



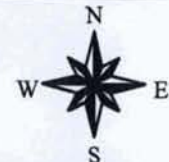
NO PARKING ZONE
