
Diane Mejia, IHSS Provider in Merced County, also spoke against the proposed IHSS Provider wage reduction. She noted the increased cost of living costs for residents, and asked the Board to keep the Providers at their current salary.

Michael Torres, an IHSS Provider, noted that he currently is allocated 9/10th of an hour to take care of his client which equal \$8.52 per day. He does all the grocery shopping, house cleaning, and cooks 3 meals a day for his IHSS client. He spoke regarding the IHSS Fraud Investigators and suggested having the Social Workers do the investigations.

April Premo spoke regarding the 7th Amendment of the U.S. Constitution and related it to the IHSS program.
