Dear Supervisor Chiesa,

Trustee Rodman Hooker's term of office expires on January 3, 2011. Trustee Hooker would like to continue as a Stanislaus County representative on the Board of Trustees. He would like to serve another two (2) year term. Trustee Hooker is currently serving as Vice-President of the Turlock Mosquito Abatement District Board of Trustees for this calendar year. He actively participates on decisions made at the Board meeting. Trustee Hooker has served on the Board since March 27, 2007.

According to the Following section of the California Health and Safety Code the appointing authority can appoint their representative to serve either a two-year term or a four-year term.

Health and Safety Code, Division 3, Chapter 1, Mosquito Abatement and Vector Control Districts, section 2024 (a) and (b) states that: “ (a) Except as provided in Section 2023, the term of office for a member of the board of trustees shall be for a term of two or four years, at the discretion of the appointing authority. Terms of office commence at noon on the first Monday in January. (b) Any vacancy in the office of a member appointed to a board of trustees shall be filled pursuant to Section 1779 of the Government Code. Any person appointed to fill a vacant office shall fill the balance of the unexpired term.

The District recommends that you take action to appoint a representative before the Turlock MAD board meeting in January 2011 so that there is no interruption of representation for the County.



**As a reminder newly appointed and re-appointed Trustees** to the Turlock Mosquito Abatement District Board of Trustees must take the Oath of Office and that the signed oath must be filed with the District clerk. The oath of office to Trustees may be delivered by county and city clerks and deputy clerks; state executive officers; and, state legislators. For special district officers, such as the Turlock MAD, the signed oath must be filed with the Turlock MAD clerk. It should not be filed with the County clerk.
