#### SUBJECT:

Approval to Introduce and Waive the First Reading of an Ordinance to Establish a New Fee for Processing Delayed Claims for an Exclusion from Reassessment for Transfers Between Parents-Children and Grandparents-Grandchildren for the Assessor's Office

#### STAFF RECOMMENDATIONS:

Approve the introduction and waive the first reading of an ordinance to establish a new fee for processing delayed claims for an exclusion from reassessment for transfers between parents-children and grandparents-grandchildren for the Assessor's Office.

#### FISCAL IMPACT:

Approval of this ordinance would allow the Assessor to recover costs associated with unnecessary reassessments of properties caused by the failure of the transferee to timely file the necessary exclusion claim forms. On average, approximately 30 claims are filed untimely each year. This ordinance will result in a revenue increase of approximately \$5,250 per year to cover the cost of processing the claims after a reappraisal has been done. This anticipated revenue increase will be effective July 1<sup>st</sup> of Budget Year 2011-2012.

### DISCUSSION:

The following fee schedule (Attachment A) is proposed by the Stanislaus County Assessor's Office. There are no changes to the existing fees but request the approval of a new fee.

Revenue and Taxation Code Section 63.1 allows transfers of property between parents and children, as well as grandparents and grandchildren to be excluded from reassessment. The eligibility requirements include the filing of a claim within three years from the date the property transferred. During this lengthy filing period, the Assessor is obligated to timely reassess the property for the annual assessment roll. Due to this incongruity in the law, the claims are frequently submitted to the Assessor after the property is reassessed and a tax bill has been issued reflecting the new assessed value. When this occurs the new assessment must be reversed causing a duplication of work.

To minimize the adverse impact on county assessors, new legislation was passed and became effective on January 1, 2009. Senate Bill 1233 amended the Revenue and Taxation Code by adding Section 63.1(j). The amendment authorizes the County Board of Supervisors to require the property owner to pay a one-time processing fee if the property owner delayed responding to two notifications from the Assessor. The fee is intended to be an incentive to file the claims when requested by the assessor. In the case of delayed filing, the fee recovers the costs incurred when the assessments must be reversed. The maximum allowed by law is \$175 per claim.

### Recapturing Costs

The Assessor is proposing a processing fee of \$175 since the actual costs calculated slightly higher at \$189. This includes direct and indirect costs, such as personnel, supplies, fleet usage, and computer costs. It is anticipated that Stanislaus County will increase revenues by approximately \$5,250 in the 2011-2012 Budget Year.

### **Comparison Counties**

In researching this new fee the Assessor surveyed other county Assessor's offices. Attached is a chart showing the counties that have implemented the fee pursuant to Revenue and Taxation Code section 63.1(j). (Attachment B) Results show not all counties have implemented this fee at this time. Some counties have indicated they are in the process of pursuing this fee with their Board. The counties that have implemented the fee are using \$175 per claim.

### POLICY ISSUE:

The Board of Supervisors should determine if the approval of the new fee supports the Board's priority of Efficient Delivery of Public Services.
