Approval to Restore Unfunded Positions as a Result of Senate Bill 89 Funding - Probation

DISCUSSION:

Senate Bill 89 restored the funding for programs that were previously funded under the Vehicle License Fee (VLF) program. This revenue supported administrative, supervisory, and front line probation operations that were reduced with the uncertainty of the funding source. The Probation Department previously received \$1,191,952 in Fiscal Year 2010-2011 to support these programs. The legislation restored this funding using a combination of a vehicle registration fee and a portion of state sales tax. The total restored funding amount is approximately 1.2 million dollars.

The Department is requesting to restore positions that had previously been unfunded due to the uncertainty of the VLF funding source. Given the new funding and its more stable source it is appropriate to return the positions to funded status so that the associated programs can be returned to full operation. It is imperative that the Department begin the hiring and background process as soon as possible in order to have all justice programs operational and to be ready to supervise the realigned population beginning October 1, 2011. At this time, the Department is requesting to restore only a portion of the positions previously unfunded and will return at a later time for the remaining positions once more specific funding information is available.

POLICY ISSUES:

Board approval of the recommended designations ensures the county is in compliance with the initial requirements of the assorted realignment legislation and supports the Board's priority of A Safe Community. Approval of the request to restore the vacant probation positions supports the Board's priority of A Safe Community and ensuring Efficient Delivery of Public Services by providing a sufficient level of administrative oversight for expanded criminal justice programs.

STAFFING IMPACTS:

The positions recommended to be restored include one Probation Manager IV (9942), one Supervising Probation Officer (9108), one Deputy Probation Officer III (9944) and four Deputy Probation Officer I/IIs (9945, 9946, 10629 and 10630). These positions support the Juvenile Justice Crime Prevention Act programs.

It is recommended that the Salary and Position Allocation Resolution be amended to reflect the recommended position changes effective the first pay period following the Board of Supervisor's approval.
