FISCAL IMPACT (Continued):

The formation, management, bonds, facilities and annexations of a Veterans Memorial District is governed by California Military & Veterans Code (M&V) sections 1170 through 1259.

M&V section 1179 outlines the election process for the formation of a Veterans Memorial District. Since the supporting petition was certified on February 3, 2012, the District measure may be consolidated with the June 5, 2012 Presidential Primary Election. The approximate cost is anticipated to be \$.25 to \$1.00 per voter, the cost which would be paid for by the County. The total cost is estimated to be approximately \$56,250 to \$225,000. If the measure is not consolidated with the June 5, 2012 Presidential Primary Election, it will create a special county-wide election which would cost approximately \$2.50 to \$3.75 per voter, or a total cost of \$562,500 to \$843,750. Stanislaus County currently has approximately 225,000 registered voters.

Pursuant to M&V section 1195, if the formation measure is approved by the voters, all future District elections will coincide with odd year Uniform District Election Law (UDEL) elections. At this time the cost of inclusion in a UDEL election would range between \$.50 to \$1.25 per voter.

DISCUSSION:

A Veterans Memorial District is a special District established by the vote of the people to provide comprehensive support to veterans with a focus on providing and maintaining memorial halls, assembly halls, or other meeting places for the use of veterans and others.

On October 11, 2005 the Board of Supervisors accepted a presentation by representatives of several veterans groups regarding the potential for a Veterans Memorial District and voted to approve the following staff recommendations:

- 1. Approve the County-wide Veterans Memorial District and Facilities Master Plan.
- 2. Support the request by the Stanislaus County Veterans Memorial District Committee to proceed to collect signatures of local voters for the formation of a Veterans Memorial District and the election of District Officers for possible inclusion on the June 2006 Primary Election ballot.
- 3. Direct the staff to return to the Board of Supervisors upon the collection of 7,985 valid signatures to qualify this measure for the ballot as certified by the County Clerk-Recorder as prescribed by law from both the incorporated city territories and the unincorporated areas of the County.

Veteran representatives independently organized the Veterans Memorial District Committee to petition a county-wide ballot initiative for the creation of a new Stanislaus County Veterans Memorial District and for the election of a new, five-member Board of Directors. The broad purpose of the proposed Veterans Memorial District will be to plan new veterans' facilities, to allow for the coordinated delivery of services to veterans, and to seek a source of funding in the future to pay for the proposed facilities.

The Military and Veterans code addresses the process for placing a District initiative on the ballot. A petition must be filed with the County Clerk-Recorder that contains at least eight (8) percent of the number of votes cast in the proposed District (Stanislaus County) for the office of Governor at the last general election at which a Governor was elected for both the incorporated and unincorporated areas. In the November 2, 2010 Gubernatorial Election 120,330 total votes were cast for the office of Governor in Stanislaus County. In the unincorporated area 25,585 votes were cast of which 2,055 sufficient signatures were received which is over the eight percent required. In the incorporated area 94,745 votes were cast of which 8,893 sufficient signatures were received which is also over the eight percent required. (see attached)

Local veteran organizations circulated and filed the required number of signatures as of February 3, 2012 to bring the proposed formation of a Stanislaus County Veterans Memorial District before the Board of Supervisors. The County Clerk-Recorder has certified that the petition contains more than the minimum requirement of at least 9,627 valid signatures (7,580 from the incorporated area and 2,047 from the unincorporated area) in order for the Board of Supervisors to call for an election to vote on the question of forming the special district and the election of five (5) officers of the District. The election requires a simple majority vote to pass.

Upon the Board's determination of sufficiency of the petition, it shall set the time and place of a hearing to take place not less than 20 nor more than 40 days from February 14, 2012 and direct the Clerk of the Board to publish a notice once a week for three successive weeks in a newspaper of general circulation. At the Public Hearing, the Board of Supervisors may:

- Call for a special election to vote to approve formation of the proposed district and elect five District board members (M&V section 1178);
- Exclude any territory that in the Board's opinion is not benefited by inclusion in a district (M&V section 1177.6); or
- The Board may adopt an order abandoning the creation of a district (M&V section 1178).

It is anticipated that, in future years, the District's Board may develop a specific plan for facilities and return to the voters to seek a property tax levy to fund the capital project effort. Any future property tax assessment would require a two-thirds majority approval of Stanislaus County voters at that time. The special District may also incur, through the Board of Supervisors, bonded indebtedness for the purpose of exercising any powers of the District. Until such revenue generating actions are implemented, the cost of holding county-wide bi-annual odd year elections must be borne by the County General Fund.

POLICY ISSUE:

The Board of Supervisors is asked to determine whether approval of this agenda item to accept the Clerk Recorder's certified statement of the results of the Stanislaus County Veterans Memorial District Formation Petition and set a public hearing on the matter of the formation of a memorial District is consistent with the Board of Supervisors' priority of Effective Partnerships.

STAFFING IMPACT:

The Military and Veterans Code requires the County Treasurer-Tax Collector to levy and collect District property tax assessments; the County Auditor is required to draw warrants against funds held by the County Treasurer-Tax Collector to pay District bonds and debts; the County District Attorney is required to provide legal advice and assistance in all district matters; the County Clerk Recorder is required to record a complete certified copy of the statement of election results and the petition for formation.
