### **FISCAL IMPACT:**

In Fiscal Year 2009-2010, the County paid \$74,391.00 to an outside vendor to administer the Volunteer Program. Beginning in January 2011, when the County resumed administration of the Volunteer program, the cost was reduced to an estimated \$8,070.00 annually which includes approximately 260 hours of staff time in the Chief Executive Office and \$48.00 which is the annual cost of the subscription to Volunteer Match for the Community Leader account. The Community Leader account provides the County with recruiting tools through the online network, the ability to post unlimited volunteer opportunity listings, reposting privileges, online referral management, tracking and reporting tools, and enhanced listings on our website. With the support of Department Heads and Department Volunteer Coordinators, the County has a successful Volunteer Program that has saved the County over \$66,000 in the last year.

Volunteers provide many intangible benefits, making it difficult to quantify the value of a volunteer program. However, with over 1,000 volunteers providing 60,802 hours of service to the County, it is clear there is a significant value to having a robust volunteer program.

### DISCUSSION:

From July 1, 1997 to December 31, 2010, Stanislaus County United Way administered the Volunteer Program for the County. As part of the overall budget cost cutting strategy, the County resumed administration of the Volunteer Program effective January 1, 2011. The Chief Executive Office—Human Resources Division is responsible for coordinating the overall Volunteer Program with the assistance of Department Volunteer Coordinators identified by participating departments. The Auditor-Controller's Office and CEO-Risk Management worked collaboratively with the Chief Executive Office to help launch the Volunteer Program and continue to provide assistance. Administration of the County's Volunteer Program is decentralized with departmental volunteer programs varying considerably in size, scope, services, complexity, and practice. Departments participate in the program at the discretion of the Department Head.

### **Value of Volunteer Program**

Stanislaus County has a long and proud history of volunteer service. Currently the County has approximately 1,063 volunteers serving 13 departments. The County believes this is an increase in the number of volunteers and volunteer hours over previous years. However, the number of volunteers and their hours may not have been accurately reported in the past, so a side-by-side comparison is difficult.

Volunteers are actively working to meet the needs of various County departments with services ranging from assisting patients at Health Services Agency, acting as translators, bringing homebound individuals library materials and taking care of abandoned animals at the Animal Shelter. Volunteers also provide much needed support to those citizens needing math, computer, and GED tutoring.

Departments with active volunteer programs readily acknowledge that their service to the public would suffer without the time, effort, and special contributions of their volunteers. The use of volunteers allows for the enhancement of services to the Community by providing services and completing tasks which departments may not be able to otherwise provide. Considering the difficult fiscal constraints facing County departments, the use of volunteers is an excellent way to use a valuable resource which already exists in the community.

Given the current economic environment in Stanislaus County and the State of California, this is an optimum time to have a robust Volunteer Program. Many highly educated and skilled individuals are currently unemployed and are seeking new employment experiences. Volunteer positions can help provide the training and on-the-job experience these individuals are seeking.

The Volunteer Program is also an excellent way to connect people with opportunities to serve County Departments and form meaningful partnerships. Through their participation, volunteers can develop and share with members of the community a greater understanding of the functions and services provided by County government and develop an appreciation for the kinds of challenges it faces.

The County is truly fortunate to have so many community members who are willing to participate in the Volunteer Program.

### **Special Volunteer Program Achievements for 2011**

- Area Agency on Aging/Friendly Visitor volunteers published their first newsletter which spotlighted both the volunteers and some of the seniors who participated in the programs.
- Behavioral Health and Recovery Services (BHRS) had several volunteers either working toward or completing their counseling certification.
- Cooperative Extension made a significant contribution to the Volunteer Program. The County 4-H program is the second largest 4-H program in the State with almost 1,500 youths. Although the program is administered by the University of California, it is run out of the local County Cooperative Extension office, is supported by a County paid Administrative Clerk, and directly benefits the residents of Stanislaus County. Last year 526 adults volunteered 16,842 hours in support of the Stanislaus County 4-H program. Activities included working at the Stanislaus County Fair, 4-H summer camp, working on newsletters in the UC Cooperative Extension office and serving on various councils, committees and boards to support the activities of 26 4-H clubs. 4-H clubs do more than raise animals; they are also involved in science literacy, entomology, geology, sports, nutrition, construction and building, engineering, GIS and GPS, small engines, sign language, citizenship, community service, public speaking and leadership development, among other things.
- Health Services Agency, the Volunteer Board initiated a scholarship fund for Modesto Junior College (MJC) students who were accepted into the first year of the Nursing Program. Two scholarships of \$500 each were awarded to exceptional students in Stanislaus County.
- Library volunteers participated in the Read to a Dog Program. This program is designed to allow children the opportunity to read to a non-judgmental listener which helps them to relax and have fun while reading and to think of themselves as good readers.
- Library volunteers also participated in the El Dia De Los Ninos, El Dia De Los

Libros (Day of the Kids, Day of the Books) celebration that highlights linking all children with books, languages, and cultures.

- Parks and Recreation volunteer achievements included campground monitoring for safer and cleaner facilities, reduction in theft and vandalism, and assistance with maintenance and repair projects. Volunteers provided education to the community regarding the County's parks, nature and wildlife. Volunteers also provided visitors with information on the Department's rules, regulations and fees, and maintained databases for more efficient tracking of inventory, labor, and expenses.
- A Public Works Transit Division volunteer completed the conversion of old computer files to current software formats. Transit staff had wanted to do this for several years but did not have staff time. This conversion allowed the Transit Division to put old data into a more usable format that can now be collated, merged, and manipulated more easily.
- Treasurer Tax-Collector Revenue Recovery Division volunteers provided assistance in the initial cleanup of the database to identify deceased individuals which ultimately resulted in cost savings by stopping collection efforts on these accounts.

### **Volunteer Fund Raising**

Health Services Agency Volunteer Services runs a gift shop, hosts book fairs and receives scholarship donations. Proceeds are donated in the form of equipment purchases for clinics, stickers for minor patients in all clinics, and monies for the Health Services Agency Adopt-A-Family Program. In 2011, donations equaled \$4,895.52. In 2012, Health Services Agency Volunteer Services will celebrate 48 years of service and a total donation of monies equaling \$323,691.76.

### **Program Goals**

The County plans to enhance the number of departments participating in the program next year by having additional departments, such as the Sheriff's Department, join the program. It is important to encourage and assist departments to expand their use of volunteers and to be creative in developing new volunteer opportunities.

Chief Executive Office—Human Resource Division will continue to administer the program and meet quarterly with Departmental Volunteer Coordinators to learn from each other's experiences. Meeting quarterly will help to open the lines of communication between departments and encourage them to share ideas and information about volunteer opportunities in their respective departments and ways to improve the program.

The Volunteer Program will be presenting information at the pre-retirement meetings sponsored by StanCERA which will be a good way to capture the interest of County employees who are planning to retire.

### **Volunteer Opportunities Website**

The County's website has a new link on the homepage next to "Job Opportunities" that says "Volunteer Opportunities." This link takes prospective volunteers to a newly created website page. Features of the website include: links set up for current Stanislaus County Government Volunteer Opportunities through Volunteer Match, names of Department Volunteer Coordinators, volunteer forms, and program resources such as the new Policies and Procedures Manual. Volunteers can readily see volunteer opportunity postings as well as download and print an application form. The County Volunteer Match Community Leader account has had 25,901 page views, referred 920 volunteers, and posted 42 new volunteer opportunities between January 1, 2011 and December 31, 2011. ### **Tracking Volunteer Hours Using PeopleSoft**

PeopleSoft is the human resource management system (HRMS) software provided through Oracle Corporation that the County currently uses to enter time and labor for paid employees. The County received permission from PeopleSoft to use this reporting software to track volunteer hours. Each volunteer is set up as a person in the "Volunteer Company," created in PeopleSoft to track volunteers and their time. The "Volunteer Company" is completely separate from all paid County employees and Volunteer Coordinators must receive special security clearance from the Auditor-Controller's Office to access the system. Departments are able to track volunteer hours by program, function, and/or location. For example, Area Agency on Aging/Veterans Services tracks the Friendly Visitor and Peer Counseling Programs. Health Services Agency tracks volunteer hours at the McHenry, Paradise, Ceres, and Turlock Medical Offices, and also by function such as pediatrics, pharmacy, rehabilitation, public health, gift shop, and human resources. The library is able to track volunteer hours at each of the 13 branch libraries.

Volunteer Hours are entered into PeopleSoft on a monthly basis. This professional method of tracking hours enhances the credibility of the County Volunteer Program by accurately reflecting the hours volunteers work without compensation. Each department must maintain a record of hours worked by each volunteer. Smaller departments generally have the Volunteer Coordinator enter volunteer hours, while a larger department may have a volunteer enter the volunteer hours. Volunteer hours were not tracked in PeopleSoft when the

Stanislaus County United Way administered the program.

### **President's Volunteer Service Awards Program**

Stanislaus County has recently been approved as an Official Certifying Organization for the President's Volunteer Service Awards Program. As a Certifying Organization, the County verifies each individual's volunteer hours and distributes the Award to those who meet the award criteria. Established in 2003, this award honors individuals who have demonstrated a sustained commitment to volunteer service over the course of 12 months. The President's Volunteer Service Award is issued by the President's Council on Service and Civic Participation on behalf of the President of the United States to recognize the best in the American spirit and to encourage all Americans to improve their communities through volunteer service and civic participation.

To be eligible to receive the President's Volunteer Service Award, the applicant's service hours must be confirmed by a registered Certifying Organization. There are three levels of the Award varying by hours of service completed within a 12 month period. The County would like to recognize and celebrate ordinary people doing extraordinary things to improve Stanislaus County. The awards are as follows:
