This letter is to advise you that Mi Pueblo Food Center will be closing one of its grocery stores in Modesto, California. In accordance with the provisions of and regulations under the Worker Adjustment and Retraining Notification Act (WARN) and applicable state law, we are providing you with notification. 2. Statement of planned action:

This will be a permanent closure of the entire store.

3. Expected date of separations and anticipated schedule:

It is anticipated that the employee separation will commence on or about July 9, 2012 and conclude on or about July 31, 2012, or within 14 calendar days thereafter.

4. Job titles of positions affected and number of affected employees in each classification:

The total number of affected employees is 85. Please see the table below for details.

5. Bumping rights:

There are no bumping rights in existence; however, some of the employees may post/apply for a transfer to other Mi Pueblo grocery stores that have current vacancies.

6. Union representation:

There are no unions representing the affected employees.

Eligible employees will receive 60 days' notice or 60 days' pay and applicable benefits in which they are currently enrolled, or a combination of the two.


