SUBJECT: MENTAL HEALTH BOARD

We received the attached applications for appointment to the Mental Health Board from Alfred Garcia, Diana Orem and Jerald Rhine.

Mr. Garcia resides in District 3, and there is a vacancy in District 3. We request that Mr. Garcia be appointed to the vacancy in District 3. Mr. Rhine also resides in District 3 and with the appointment of Mr. Garcia, there will no longer be a vacancy in District 3. There is a vacancy in District 1, and an out-of-district appointment is requested for Mr. Rhine. Ms. Orem is a resident of District 2, and there is also not a vacancy in District 2. There is, however, a vacancy in District 4. We are also requesting an out-of-district appointment for Ms. Orem. With the appointment of the three applicants, the membership of the Mental Health Board will be full.
