This memo is to notify you that Turlock Mosquito Abatement District Board of Trustee members Rodman Hooker and Dan Peterson are interested in being considered for re-appointment. Both member terms expire on January 7, 2013 and both have expressed an interest in continuing to serve on the Board for another two (2) year term. Trustee Rodman Hooker is currently serving as Vice-President of the Turlock Mosquito Abatement District Board and both members are active members of the Board in good standing.

The District recommends that you take action to appoint a representative before the Turlock Mosquito Abatement District Board Meeting in January 2013 to avoid any interruption in representation for the County-at-Large.

As a reminder, newly appointed and re-appointed Trustees to the Turlock Mosquito Abatement District Board must take the Oath of Office and that the signed oath must be filed with the District clerk. The oath of office to Trustees may be delivered by county and city clerks and deputy clerks, state executive officers, and, state legislatures. For special district officers, such as the Turlock Mosquito Abatement District, the signed oath must be filed with the Turlock Mosquito Abatement District Clerk. It should not be filed with the County Clerk.
