FISCAL IMPACT:

The total estimated cost for this project is \$1,535,951. The project is funded with \$1,535,951 of Federal Regional Surface Transportation Program (RSTP) utilizing toll credit. Funding is available in the Fiscal Year 2012-2013 Road Projects budget.

DISCUSSION:

The RSTP Road Resurfacing Program provided funding for Phase A (completed 2009), Phase B (completed 2010), Phase C (completed 2011), and Phase D (completed 2012) overlay projects. A total of 85.45 miles of roadway was resurfaced during these phases.

The RSTP Road Resurfacing Program Phase E project will consist of placing asphalt-concrete overlay onto 8.1 miles of road surfaces, thereby creating a smooth, durable, water resistant pavement surface. New striping will be applied on the centerline and edge lines, as well as various pavement markings. Shoulder backing will be placed to stabilize the road shoulders.

All preliminary engineering was completed by Public Works staff.

The following roads are included in the RSTP Road Resurfacing Program Phase E project:

1. Condit Avenue (Cox Road to Vineyard Avenue) – 0.9 mi.
2. Sycamore Avenue (Fruit Avenue to Patterson City Limits) – 1.5 mi.
3. Sycamore Avenue (Fig Avenue to Marshall Road) – 2.6 mi.
4. Fruit Avenue (Vineyard Avenue to Sycamore Avenue) – 0.2 mi.
5. Vineyard Avenue (Condit Avenue to Fruit Avenue) – 0.8 mi.
6. Hills Ferry Road (Newman City Limits to Merced County Line) – 2.1 mi.

This project is exempt from the California Environmental Quality Act, Class 1, California Code of Regulations, Title 14, §15301 (Existing Facilities). On October 22, 2012, Stanislaus County filed California Environmental Quality Act (CEQA) Categorical Exemption determination for the project.

National Environmental Policy Act (NEPA) clearance was obtained on May 24, 2012, by Caltrans. The project is a Categorical Exclusion under 23 CFR 771.117 activity (d)(1).

POLICY ISSUES:

The recommended actions are consistent with the Board's priorities of providing A Safe Community, A Healthy Community, and A Well Planned Infrastructure System by continuing the maintenance of Stanislaus County's road system.
