INVOLVING THE TRANSFER OF UP TO 3,658 ACRE-FEET OF WATER  
FROM CITY OF SACRAMENTO AND SACRAMENTO SUBURBAN WATER DISTRICT  
TO STATE WATER CONTRACTOR AGENCIES  
UNDER PERMIT 11360 (APPLICATION 12622)**

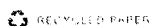
On May 10, 2013, the City of Sacramento and Sacramento Suburban Water District filed a petition for temporary change to transfer up to 3,658 acre feet of water pursuant to Water Code section 1725 et seq., under water right Permit 11360 (Application 12622). Surface water will be made available for transfer via groundwater substitution and will be provided to the following State Water Contractor Agencies: Kern County Water Agency, Dudley Ridge Water District, and Empire-West Side Irrigation District. The proposed change will include the temporary addition of the following to Permit 11360: (1) the State Water Project's (SWP) Harvey O. Banks Pumping Plant as a point of rediversion; (2) a portion of the service area of the SWP to the place of use; and (3) irrigation as a purpose of use. Temporary changes under Water Code section 1725 may be effective for a period of up to one year. 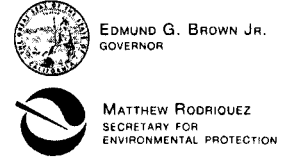

**NOTICE OF PETITION FOR TEMPORARY CHANGE INVOLVING THE TRANSFER OF UP TO 4,000 ACRE-FEET OF WATER FROM DAVID AND ALICE TE VELDE REVOCABLE FAMILY TRUST TO THE SAN LUIS AND DELTA-MENDOTA WATER AUTHORITY UNDER LICENSES 9994, 9995, 9996, AND 9997 (APPLICATIONS 3423, 4901, 4902, AND 5359)**

On May 8, 2013, David and Alice Te Velde Revocable Family Trust (Family Trust) filed four petitions for change with the State Water Resources Control Board involving the proposed temporary transfer of up to 4,000 acre-feet (af), of a combined 7,575 af of water available under the petitioner's licenses, to the San Luis and Delta-Mendota Water Authority (Authority) pursuant to Water Code sections 1701 and 1725. The transfer water would be made available by ground water substitution for surface water under the Family Trust's licenses to provide an additional supply of water to the Authority for irrigation.
