

ORDINANCE NO. C.S. 1135

AN ORDINANCE AMENDING CHAPTER 3.08 OF THE STANISLAUS COUNTY CODE RELATING TO THE POSTING REQUIREMENTS FOR COUNTY RECRUITMENTS

THE BOARD OF SUPERVISORS OF THE COUNTY OF STANISLAUS, STATE OF CALIFORNIA, DO ORDAIN AS FOLLOWS:

Section 1. Section 3.08.160 of Chapter 3.08 of the Stanislaus County Code is amended to read as follows:

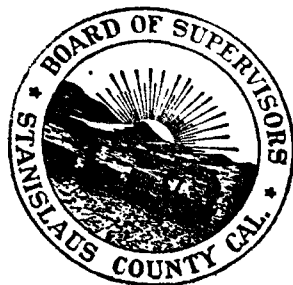
“There shall be a reasonable period for the filing of applications for positions in the classified service. Announcements shall be posted for a period of at least five working days prior to the final date to file an application for open and promotional competitive full-time positions. Final filing dates may be extended by the personnel department.

(Ord. NS 1021 §1, 1981; prior code §2-180.7).”

Section 2. This ordinance shall take effect thirty (30) days from and after the date of its passage and before the expiration of fifteen (15) days after its passage it shall be published once, with the names of the members voting for and against the same, in the Modesto Bee, a newspaper published in the County of Stanislaus, State of California.
