I am writing this letter to let you and the Board of Supervisors know that I am interested in continuing serving as a Commissioner for the Stanislaus County, Children & Families Commission.


I enjoy working together with the rest of the commissioners and consider an honor to be of service to the community in the Stanislaus County where I live.
