BOARD OF SUPERVISORS

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OAKDALE AS FOLLOWS:

1. The City Council hereby declares that an election shall be held in the City of Oakdale, County of Stanislaus, State of California, on Tuesday, November 4, 2014 at which election the following offices shall be filled:

One Mayor for the full term of four years.
Two Council Members for the full term of four years.

2. The Board of Supervisors of Stanislaus County is hereby requested to consolidate said election with the General Election to be held on November 4, 2014.
3. That the Stanislaus County Registrar of Voters is hereby authorized to render services, including but not limited to, printing and mailing voter pamphlets, the preparation and tabulation of the results of the votes cast, and canvassing the returns of the election.
4. The City shall reimburse the County for the actual cost incurred in conducting the election.
5. In accordance with California Election Code Section 9205, the City Clerk is directed to publish public notice of the election in a newspaper of general circulation.
